# Just Transition Local and Regional Economic Support Strategies Support Scheme

LA led LECP aligned project applications — Offaly County Council applied for funding for an Economic Development Unit to support the objectives of the *Local Economic and Community Plan 2024-2029* and the *Offaly Economic Development Strategy and Action Plan 2022-2027.* The closing date was 8th December 2023. A funding announcement for successful applications is imminent.

**LECP aligned projects** – Offaly County Council submitted four applications by the closing date of **23rd January 2024** for projects in Shannonbridge, Tullamore and Rhode, together with an application for a resource for FilmOffaly. A funding announcement for successful applications is expected in **April 2024.** 

#### Fáilte Ireland


Under the Strategic Partnership Agreement which was signed in November 2023 between Offaly County Council and Failte Ireland, Offaly County Council submitted three applications by the closing date of 29th February 2024, under the Regenerative Tourism and Placemaking Scheme for Ireland's Midlands 2023-2026. The applications were in relation to projects in Birr, Shannonbridge and Portarlington.

# **Residential Zoned Land Tax (RZLT)**

Offaly County Council published its Draft map RZLT 2024 on 1 February showing land to be considered in scope for the RZLT maps along with explanatory text to accompany same and inviting submissions from landowners in relation to removal of land from draft maps (by 1 April) and zoning requests (by 31 May).

# Architecture and Conservation – January to February 2024

- Birr Destination Town Failte Ireland funding, new entrance to Birr Demesne. Works practically complete. Pedestrian access from The Green to the new entrance to be carried out by Birr MD.
- 2. Built Heritage Investment Scheme 19 projects sent to the Department for approval, total funding of €126,400 and ring-fenced thatching funding of €10,144. This is subdivided among four proposed thatch projects for 2024.



3. **Historic Structures Fund** – A total of six projects sent to the Department, decision to be announced early March. *Proposed HSF projects shown in green on map above.* 



Birr Suspension Bridge – HSF 2023, completed repairs to the bridge. An event organised with Birr Primary School and Birr Secondary School to celebrate the project in conjunction with Engineers Week.



4. Community Monuments Fund – application submitted by HO for conservation repairs to Toberdaly Folly, awaiting decision by Department. This work follows on from successful Heritage Stewardship Fund in 2023 and the Conservation Management Plan, prepared by HHC.



# 5. Heritage Council:



- a. Heritage Stewardship Fund application submitted with the Irish Georgian Society to run a Traditional Skills weekend in Birr, June 2024. Awaiting decision by Heritage Council. If successful it will be based in Birr Theatre and along Oxmantown Mall. Sample event held in Dublin 2022.
  - b. Heritage Office A short film on the unique craft of God-in-a-Bottle and the two makers in Offaly, Pat Gorman, Killurin and Ned and Eddie Hendrick, Shannonbridge. Working with the successful tender to produce this short film in 2024.



- c. **Heritage Forum** attend and update quarterly meetings.
- 6. Creative Ireland two areas of funding Folly, will combine with CMF for Toberdaly Folly and Traditional Architecture. A new film on Thatching in Offaly has been commissioned. It will focus on Ben Purcell in Derrybeg and his son Tony Purcell, thatching their house outside Tullamore.



- 7. **Traditional Architecture in Offaly,** by Rachel Mc Kenna, sold out to be reprinted with a further 500 copies.
- 8. Follies Trust three-day visit to Offaly. A group of 36 have booked into Kinnitty Castle (only available date and location for that many people) in September. Arranging access to suitable site for the group with commentary over the three days, Sunday to Tuesday. This is their second visit as a group to the county (2019) and they have also agreed to assist with funding towards the 2024 folly project. Follies Trust visit to Ballycumber gazebo in 2019

# Clara Town Team recognised at national Town Centre First launch event 28<sup>th</sup> February 2024.

Clara was among 26 towns across Ireland off and running on an ambitious, multimillion-euro government initiative to breathe new life into their town centres. The Town Team responsible for developing the Clara 'Town Centre First' plan was recognised at the event held in Limerick, attended by Minister for Rural and Development, Heather Community Humphreys and Minister of State for Local Government and Planning. Kieran O'Donnell.

Offaly Town Regeneration Officer, Olwen Cummins, Andrew Murray A/Director of Services along, with Anna Orman and Mary Delaney representatives from Clara's Town Team, attended the event. The event recognised the 26 towns and communities that are now moving forward with ambitious plans to breathe new life into their areas under the Town Centre First Programme.

# **Town Centre First - Suite of Supports 2024**

The Minister for Rural and Community Development, Heather Humphreys TD, announced on 7<sup>th</sup> February 2024 a €4.5 million package to support our rural towns and villages. As part of a suite of measures, a new Town Team Support Fund will be established to build and develop a network of Town Teams nationwide.

The new package is designed to further enhance government support towards the revitalisation of rural towns and villages, making them more attractive places in which to live, work, visit and invest.

The new package of supports will support the following measures:

- Town Team Support Fund Funding of up to €10,000 each for three towns in each eligible local authority area to support research and data collection or establishment and/or development of town teams where they are not already well established.
- Town Centre First Plan Funding of €30,000 in each eligible local authority area to support the development of a TCF plan in a rural town.
- Project Development Measure This measure will assist local authorities to contribute to a pipeline of significant, welldeveloped projects by providing funding of €50,000 each to support two projects. This support will be delivered under the umbrella of the Town and Village Renewal Scheme.

The Regeneration Team supported by the Town Regeneration Officer will apply for

the suite of supports above over the coming weeks and months as deadlines occur.

# Vacancy & Dereliction Vacant Homes Survey App

A total of 846 properties have been surveyed to date in the county with 388 confirmed vacant. Letters are continuing to issue to the owners of vacant/derelict properties on a town by town approach with the aim of bringing their property back into use.



# Croi Cónaithe – Vacant Property Refurbishment Grant

The Vacant Property Refurbishment Grant is progressing as supports continue to be available to turn vacant residential and commercial properties into private residences/rental properties. Breakdown of applications received to date:

# Derelict Sites & Urban Regeneration Development Fund (Call 3)

The Derelict Sites team continue to target Derelict properties and sites through use of the Derelict Sites Act 1990. Extensive efforts have been undertaken throughout 2023 to lay the foundations of a derelict sites team that will oversee a structured and sustained approach to addressing vacancy and dereliction that exists in Offaly's towns and villages.

As of March 2024, there are 17 sites that make up the derelict sites register of Offaly County Council. With the continuous roll out of its derelict sites policy the derelict sites team envisage this number will grow in 2024 and beyond. The team will be taking a town-by-town approach to dealing with derelict sites throughout the county.

Derelict site levies for 2024 have been issued on each of these sites and served to the identified owners of each property. All queries in relation to derelicts sites in Co. Offaly should be directed to

# **URDF Call 3**

Under Call 3 of URDF, Offaly County Council is now positioned to address dereliction and vacancy within the urban district of Tullamore Town. In 2023, the Department of Housing approved a list of 25 properties and allocated funding to activate these properties located in and near the town centre.

This approved list and allocated funding gives Offaly County Council a platform to activate properties that have, for one reason or another over time, become vacant and derelict. A dedicated team has been put in place to oversee this, the approved list is live and will constantly change as properties are added and removed. To date, a number of properties have been put on the open market, others have been activated by owner as a result Offaly County Council engagement.

Of the 25 properties on the approved list, OCC have identified owners and opened engagement with 20. To date, this engagement has yielded the following:

- 2 properties on the list are not vacant.
- 5 properties have placed on the private property market by private owners.
- 1 property is being placed on the derelict sites register of Offaly County Council.
- 3 properties are being activated by owners, a process that is ongoing.

- 4 properties explored for acquisition by compulsory acquisition/acquisition by agreement.
- 5 properties at early stages of engagement with owners and will continue.

During engagement owners are made aware of available grants to support property activation, grants such as Croí Cónaithe offers €50k for vacant properties and €70k for properties considered derelict.

Offaly County Council will continue to identify and work with owners to active properties within Tullamore. The activation of properties within the town, supports policies such as Town Centre First and Local Area Plans.



# **Housing Update**

- There are 521 on the Social Housing Support List at the end of February 2024.
- A further 580 active tenancies are currently being supported under the Housing Assistance Payments (HAP) Scheme, 7 signed up for HAP and 10 exited from HAP in February.
- At the end of February, 29 single people and 15 couples and families were being supported in emergency accommodation.
- A rent review of Social Leasing Scheme Tenants (including Rental Accommodation, Short Term Leasing, Repair & Lease and

Mortgage to Rent) and HAP Tenants has commenced. ΑII relevant Tenants have been written and outstanding assessment forms and supporting documentation should be returned immediately. Tenant queries can be directed to our email RentReview@offalycoco.ie

# **Retrofit Programme**

In deciding on a works programme, local authorities are urged to choose a mix of properties across a range of BERs to allow for homes which need significant expenditure to be balanced out by those needing lesser spend to achieve the overall average cost of €34,000 per property. A BER rating of B2 must be achieved.

# Local Community Development Committee (LCDC)

Offaly LCDC held their monthly meeting on Thursday 8<sup>th</sup> February, 2024. Main agenda



items included the Offaly LCDC Annual Report 2023, Rural Development LEADER Programme 2014 – 2022, Social Inclusion Community Activation Programme 2018-2023 (SICAP), SICAP 2024-2028, Draft Offaly Local Economic & Community Plan 2024-2029, Healthy Ireland/Offaly Fund Round 4 and Local Enhancement Programme 2024.

LCDC Annual Report 2023 The LCDC Annual Report 2023 Annual Report was adopted by the members and submitted to the elected members of Offaly County Council at the February 2024 Council Meeting. The report was presented to the members and a summary provided on the content and main achievements of Offaly LCDC in 2023 under various programmes of work.

SICAP Members agreed and adopted the 2023 SICAP Annual Performance Review and the 2023 SICAP Annual Progress Report. The SICAP Annual Plan 2024 was approved in principle.

**Draft LECP** A detailed presentation in relation to the Draft Framework Local Economic & Community Plan 2024-2029 was provided to the members. Goals and objectives were highlighted and proposed implementation, reporting structures and timeframes outlined. Members approved the Draft LECP 2024-2029 as circulated.

Healthy Offaly A comprehensive update in relation to Healthy Ireland Fund Round 4 Actions — Year 1 Results and Year 2 Proposals. The Healthy Offaly Grant Assessment Sub-Committee evaluated and proposed projects and budgets and their recommendations were put before the meeting. Members approved a wide range of projects and welcomed the invaluable progress made in the improvement of health and wellbeing of people in Offaly under the programmes.

Local Enhancement Programme 2024 An update was provided in regard to the application process and timeframes.

# **Local Enhancement Programme 2024**

The Local Enhancement Programme 2024 was announced on 6th December 2023 and opened for online applications from Monday 22<sup>nd</sup> January 2024, with a closing date of Wednesday 28th February 2024. An allocation of €127,369.50 is available for general community capital grants and €27,099.89 is ring fenced for supports for Women's Sheds, Groups and Networks in Offaly.

A total of 136 applications were received by the deadline. An evaluation committee of Offaly Local Community Development Committee (LCDC) will meet on 11<sup>th</sup> March 2024 to assess the applications and will make recommendations on successful projects to the LCDC meeting on 14<sup>th</sup> March 2024. Successful projects will be approved by the Minister in early April 2024.

# **Public Participation Network**



A number of events took place during February. This included the Funding

Roadshow coordinated by the PPN in collaboration with the Community Section. Three locations, one in each MD. Edenderry and Birr Libraries were the hosts in their MD's while Tullamore Town Hall was the location in Tullamore MD.

These funding events were well received as people had an opportunity to speak on a one-to-one basis with staff from a number of different sections withing the Council on Funding opportunities, current and potential future opportunities. All events were even more successful with the support of the staff in each of the locations.

PPN The was represented at the Diversity & Equality Toolkit launched in **February** Birr on Offaly PPN 13th. were successful in sourcing funding via Leader to undertake a Community Energy Charter. Green Offaly



won the Tender and the process of developing a Charter has commenced with a survey released to membership and the first of 3 Workshops completed on Feb 22<sup>nd</sup>

Discussion took place with the ETB and the Older Persons Network on a Pilot Historical project to be undertaken during 2024.

# Comhairle Na nÓg

Comhairle members held a number of meetings in February



to develop their workplan for 2024. They are working on a more holistic approach to what can be done to improve mental health for young people in the county.

A steering committee meeting was held, and plans were made as to how to assist the young people to progress their topic. A number of committee members expressed interest in attending the Comhairle executive meetings. An invitation has been extended from Comhairle members to the Steering committee to join them for their April meeting.

### **HEALTHY OFFALY**



February 2023 saw the results of the Healthy Ireland Round 4 year 1 actions published. Edufit were engaged to interpret

the data collected from 6 x implementing partners. The two outcome indicators chosen by Healthy Offaly were 1. 'Increase in the percentage of adults and children meeting physical activity guidelines' and 2. 'Decrease in the number of adults who are overweight and obese'. The results were extremely positive with improvements in physical activity and obesity reduction levels achieved across the board.

To summarise the results, four of the six actions can be grouped together under the 'Physical Activity' outcome indicator which were assessed using the M1 measurement tool. The results are as follows:

A total of 141 adults took part in Healthy Offaly projects which measured physical activity participation pre- and postprogramme ('Drop and Move', 'Social Farming' and 'Offaly Traveller Football Programme'). The average M1 score at baseline was 2.4 days of physical activity per week. The average M1 score following the programmes was 3.8 days of physical activity per week. This represents an average increase of 1.4 days of physical activity per week or 58.3%. For the fourth action a total of 42 children took part in the Healthy Offaly 'After Schools Physical Activity Programme' which measured physical activity participation pre- and post-programme. The average M1 score at baseline was 2.8 days of physical activity per week. The average M1 score following the programme was 5.0 days of physical activity per week. This represents an average increase of 2.2 days of physical activity per week or 78.6%.

Under the 'Obesity' intervention outcome indicator Clara Community & Family Resource Centre and Exwell Medical the 'Invest Yourself' delivered in programme. The average M1 score at baseline (start of programme) was 2.6 days of physical activity per week. Postprogramme the average score was 5.2 days. This represents an average increase of 2.6 days of physical activity per week or a 100% increase in physical activity levels. Participants were invited to have their body weight measured at the start and end the programme. Eight people volunteered to have this measurement taken. The results show an average reduction in body weight of 2kgs or 2.2% post-pilot.

The final project top note was the 'Activator Poles' programme run Kilcormac Development Association. Sixteen adults took part in this pilot programme in Kilcormac. An analysis of the IPAQ-SF calculated that the group average MET-min/week was 2074 pre-programme and 2678 post-programme. This represents an increase in MET-min/week of 604 or 29.1%. The group average time spent sedentary pre-programme was 3.2 hours and 2.8 hours post-programme. This reflects a decrease in sedentary time of 0.4 hours per week or 12.5%.

Overall, the results show that the actions undertaken have shown real and tangible improvements in the health of all participants. The 'Drop & Move', 'Children's Afterschool Physical Activity', 'Traveller Men's Football Team' and 'Invest in Yourself' programmes have been extended for 2024.

New actions approved by Offaly LCDC to proceed this year are a 'Cycling without Age' rickshaw bicycle project for Lough

Boora; 'Dance Classes for Children and Adults in Edenderry'; Support for the 'Offaly Athletics Road Race 5K Series' with Healthy Ireland as headline sponsor; 'Exercise your way to wellness' physical activity classes to be provided by Edenderry GAA Exwell & Medical; of poles provision activator Portarlington Library which is a joint initiative with our partners in Healthy Laois; 'Minding Me' a 6-week nutrition and exercise course for older adults; and 'Active Aging for Kilcormac' by Kilcormac Development Association which provide weekly Boccia, Pickleball and Activator Poles Classes for older adults. Encouraged by the excellent results from our year 1 actions we approach our programme of work this year with energy and enthusiasm. # Film Offaly Award 2024

The call for the FilmOffaly 2024 Award has been announced with a closing date of **12 noon on Monday 11th March 2024.** This funding initiative aims to foster creative, resourceful filmmaking in the county. The Award is for unique, original stories by talented new filmmakers, professional and novice alike. The only stipulation is that the filming must take place in Offaly! The Offaly Film Commission also encourage the utilisation of local crew and a mentoring element of the production for local film makers.

FilmOffaly Review – The FilmOffaly Review undertaken by researchers, *Culture Works* across is now completed. Following presentations to FilmOffaly Commission Board and Community and Culture SPC, recommendations and actions will form part of the new Arts Strategy 2024-2028.

# **Annual Programme Funding Opportunities**

The 2024 Youth Arts Commissions caters for the delivery of Youth Arts Projects for the cohort of 13- to 25-year-olds within Offaly. The Arts Office invited professional artists, individuals or groups, to work with youth organisations to submit a proposal idea. outlining the proposed The commission is open to submissions from all art disciplines including visual arts, film, animation, digital arts, performing arts, literature or sound art. The commission can concentrate on one art form or a range of art forms but must include the participation of/engagement with professional artist. Young people's active participation and the co-creation of work should be central to the youth arts projects. The funding process is currently ongoing.

The Arts Acts Grants 2024 were presented and approved in the February council meeting to a value of 19,966 euro. Grants through this scheme have been awarded to: Riverview Resources, Banagher Drama Group, Colaiste Naomh Cormac, Coolderry Central School, Crinkill N.S., Dochas Offaly, Eden Chorale, Gemini Players, Irish Midlands Youth Orchestra, Irish Wheelchair Association. Killeigh Comhaltas, Midland Strings, Co Offaly Federation ICA, Rahan Drama Group, Red Embers, St Brendan's Community School, St Brendan's PS Birr and Tullamore Musical Society.

The Professional Artists Support Award were independently evaluated, with 29 grants awarded to professional artists to a value of **15,000 euro**.

The Festival Arts Scheme 2004 is designed for festivals taking place in Offaly in 2024 that are either dedicated arts festivals or have a strong professional arts element to the festival. The Professional Artist Support Award offers a support scheme for professional artists in developing their arts practice over a number of categories, with the aim of encouraging professional artists to live and work in the county. The funding process is currently ongoing.

### **Public Art**

'FROM WITHIN' a newly commissioned piece of contemporary dance created with young people in Tullamore. The commission funding has been made available through the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under the Outdoor Public Space Scheme 2021 and is associated with the development of the new Bandstand in Lloyd Town Park Tullamore.

Local professional dancer Amy Donlon was commissioned to develop a new work of choreography working with an ensemble of young dancers from the area. The choreography explores the interplay between water, outdoor space and the connection between water and play. The newly commissioned work was performed at the Bandstand in Lloyd Park, Tullamore in February.



# **Creative Places Edenderry**

Creative Places, Edenderry, a project funded by the Arts Council, led by Creative Lives in partnership with Offaly County Council Arts Office and Edenderry Municipal District, has been hosting an array of different arts-based activities, workshops and events. February continues to see activities in a wide range of art forms including: Visual Arts, Music, Poetry, Playwriting, Creative Movement; Dance; Ceramics; Drama; Radio, Photography

Creative Places Edenderry ran an open call for their seed funding scheme, which will see a number of projects receiving funding of up to 1,000 euro for creative projects in the Edenderry Community.

# **Climate Action Local Authority Climate Action Plan**



Under the Climate Action and Low Carbon Development (Amendment) Act 2021, each local authority is required to prepare a local authority climate action plan for its respective administrative area. The guidelines have

been issued under the provisions of the Act and are therefore statutory in nature.

On the 19th February 2024, after consideration of the CE Report and AA/SEA environmental report determinations presented, the elected members of Offaly County Council adopted the Climate Action Plan 2024-2029 without amendment.

# **Community Climate Action Fund**

The Community Climate Action Fund (CCAF) was launched within Offaly on 13<sup>th</sup> December 2023, and remained open for application for 12 weeks, closing on 6<sup>th</sup> March 2024.

The Community Climate Action Programme, under the Climate Action Fund, has been developed under two strands addressing both direct climate action, and climate education and capacity building.

Strand 1 has two parts: strand 1 entitled "Action: Building Low Carbon Communities" for €24 million, and strand 1a entitled "Shared Island Community Climate Action" for €3 million.

Strand 1: Action: Building Low Carbon Communities

€444,000 is being provided to Offaly Co. Co. to work in partnership with communities, large and small, rural and urban, within their areas of operation to build low carbon communities in a considered and structured way. The projects will address the following five themes:

- Home/energy
- Travel
- Food and waste
- Shopping and recycling
- Local climate and environmental action

Offaly County Council received 23 no. application for Strand 1, and are currently assessing applications to avail of the €444,000 allocated for community groups in Strand 1. Suitable projects will receive 100% funding and must be completed within 18 months of the signed grant agreement (between OCC and relevant community group). It is anticipated that grant agreements will issue to successful applicants in August, following DECC approval. The Community Climate Action Officer (Sinead McEvoy) is co-ordinating this fund within Offaly Co. Co.

# **Green Awards**

Offaly County Council were shortlisted for the *Green Awards 2024, Green Business & Sustainability* in the category of "*Green Public Sector Organisation of the Year*" following submission of our comprehensive application.

A record 250+ entries were received across a range of categories and the judging panel shortlisted our application along with other public sector organisations such as An Post, CIÉ Group, DAA, Dublin Bus, Trinty College Dublin, Uisce Éireann and Waterways Ireland for the Green Public Sector Organisation of the Year award.

While Offaly County Council were the only local authority to be shortlisted as finalists, recognising our leadership in Climate Action to date. Offaly County Council were not winners on the night, with An Post taking home the award.

# **Energy**

Offaly County Council, in line with our SEAI Public Sector Partnership, have signed up to an Achieving ISO 50001 Accelerator Programme designed for the public sector to enhance their energy management structures. Currently Offaly County Council have achieved 40% energy efficiency from a baseline year, with a target of 50% by 2030. ISO 50001 accreditation will be a core enabler to achieving this target.

ISO 50001 is based on the management system model of continual improvement also used for other well-known standards such as ISO 9001 or ISO 14001. This makes it easier for organizations to integrate energy management into their overall efforts to improve quality and environmental management.

ISO 50001 illustrates Offaly County Council's leadership in Climate Action, and accelerates our journey towards an exemplar organisation in energy management. This will be a 10 month

programme with accreditation achieved by early 2025.



# **Environmental Management Submissions to EPA**

Environment Team made the annual submission to the EPA known as the RMCEI (Recommended Minimum Criteria for Environmental Inspections), detailing the numbers of environment inspections completed by Offaly County Council in 2023.

This was submitted through NEMSIS software system, supported by LGMA. The submission covers waste management, air and noise management and water quality. The programme of works is informed by the 20 National Enforcement Priorities (NEPs) which focus on delivering positive environmental outcomes for air quality, water quality and waste management. A 48-page supporting report detailing all the environment inspection work was also submitted summarising work completed, approach taken and environmental outcomes.

A submission on agricultural inspections in accordance with EPAs requirements was submitted. In 2024, there will be a renewed focus on improving agricultural compliance under the Good Agricultural Practice for the Protection of Waters Regulations. Funding has been provided to Offaly County Council for additional staff to carry out farm inspection to the end of 2027, in line with the existing Water Framework Directive and third cycle River Basin Management Plan.

A Noise Action Progress Report was submitted to the EPA outlining the noise reducing actions taken during 2023. The report focuses on progress made in urban areas and required collaboration with other sections e.g. Roads, Climate Action.

The EPA has a supervisory role in relation to the performance by local authorities of their statutory environmental protection duties. The EPA will review documentation and report on Offaly's progress in meeting agreed environmental indicators later in the year.

# **CCTV** use for waste enforcement

The Minister for State Ossian Smyth signed the commencement orders that came into effect on 15<sup>th</sup> February 2024 allowing for the lawful use of CCTV in accordance with the following codes of practice.

- 1. Code of Practice on the Operation of CCTV for the Purposes of Prevention, Detection & Prosecution of Waste Offences, under the Waste Management Act 1996 (as amended)
- 2. Code of Practice on the operation of CCTV for the

- Purposes of Prevention, Detection & Prosecution of Litter Offences, under the Litter Pollution Act 1997 (as amended)
- 3. Code of Practice on the Operation of Mobile Recording Devices for the Purposes of Prevention, Detection & Prosecution of Waste Offences under the Waste Management Act 1996 (as amended).

Due to the complexity of legislation surrounding data, the code require various procedures around establishing the need for CCTV, adjudication aby an oversight board, and permission by CE order. Offaly County Council will establish an Oversight Board who will analyse the use of CCTV and a Business Case and Data Protection Impact Assessment (DPIA) will be considered by the Board for the use of CCTV

Pilot studies in the three Waste Regions are currently being conducted and in the Eastern Midlands Waste Region, Dun Laoghaire Rathdown Co. Co. was selected. Once the pilot has been completed Offaly County Council will be working in conjunction with WERLA in implementing the conditions adopted in the Codes of Practice. Upon establishing appropriate structures and safe-guards, CTTV will be available within the tool-kit of Offalv County Council litter and enforcement teams, funding permitting.

### **Burial Grounds**

**St. Mary's Cemetery, Edenderry:** We will be appointing the contractor for the extension in the coming months.

Cemetery Committees: We currently work with 17 cemetery committees, and we look forward to working with new committees in 2024. There are grants and assistance available form the CA-ENV-RW section and we welcome engagement from groups that are currently maintaining their local cemetery or planning on forming a committee to do that.



### **RURAL WATER SERVICES - Capital**

The Rural Water Unit of the Department of Housing have circulated the Multi-Annual Rural Water Programme 2024 to 2026 for capital funding for Group Water Schemes. We are currently discussing projects with the Group Water Schemes and assisting them in outing together their bids for funding. Applications are due to be submitted to the Rural Water Unit by 12/04/2024.

# Veterinary Control of Dogs

So far in 2024 we have seized or received surrenders of 50 dogs, of which we have managed to re-home 36 so far.

On average 15% of the dogs are reclaimed by their owners, 15% are rehomed by the Care of Dogs Team and the other 70% are rehomed through animal rescue charities. The Control of Dogs team has also dealt with 15 complaints so far this year and has assisted AGS on a number of raids and have carried out inspections of premises under DBE and Animal Health and Welfare legislation.

#### **Control of Horses**

To date in 2024, we have dealt with 4 complaints, there have been no seizures to date.

# **Veterinary Inspections**

Offaly County Council continues to operate the Shared Service Agreement for Veterinary Services in the Westmeath County Council administrative area.

# **2024 Road Program Allocations**

The Roads Department-has been notified of the 2024 funding allocations from the three Transport agencies, TII, Dot and the NTA. Table 1 shows a comparison of the levels of funding from each of our funding partners along with the allocation from OCC own resources. All programs other than the TII allocation show a modest increase for 2024. The reduction in the TII allocation is due to a decrease in Pavement Renewal funding for 2024 as compared to 2023 which equates to a difference of approximately €2,800,000. The allocation as shown below have now been assigned to each Municipal District and it is intended that the Annual Roads Program will come before the members at the March Meeting.
