2. Update on delivering the Offaly Heritage Plan 2017-23 and preparation of new 5-year plan

Ms. A. Pedlow, Heritage Officer summarised the Draft Offaly Heritage Plan 2023-2027. This meeting was the launch of the public consultation process for the 5-year plan. The members welcomed the report. Ms. Pedlow encouraged submissions as part of the process. It is intended to adopt the plan in Q3 2022 at plenary Council.

3. GMA Allocation

Ms. J Ryan gave a brief overview on the projects funded to date. Following a request from the members at the January meeting, Mr. Ryan suggested a number of projects for the 2022 allocation.
