Rural Regeneration & Development Fund (RRDF)

Granary Link Street project

Project works recommenced on the 10th May, anticipated to complete in 3-4 months.

Inner Relief Road Project

Final review being of tender documents being carried out by Department of Transport, with permission to proceed to tender with Phase 1 (Rosderra section) upon completion of DoT review.
