- Class 3, 5 and 12 of Part 1 of Schedule 2 of the Planning and Development Regulations 2001 (as amended).

AND WHEREAS Offaly County Council has concluded that the proposed works as detailed in the submitted documentation is development and is exempted development.

NOW THEREFORE Offaly County Council, in exercise of the powers conferred on it by Section 5(2)(a) of the Planning and Development Act 2000 (as amended), hereby decides that:

SECOND REPORT ON FILE

1. Proposal

The question has arisen whether the proposed works including removal and replacement of rainwater pipes and gutters, windows, window sills, two entrance doors, installation of new backyard fence, painting, retiling, garage redevelopment and internal works is or is not development and if so, are they exempted development.

Review of Further Information

Further information was sought by the Planning Authority on 20th December 2023 and subsequently received by the Planning Authority on 15th January 2023. This report should be read in conjunction with the previous planner's report dated 29th November 2023. The following Further Information was sought and the response is as follows:

1. The applicant has stated an intention to install a backyard fence. The applicant is therefore required to provide further information on the height of the proposed fence and to confirm that it will be situated adjoining the rear property boundary

Applicants Response: The applicant has provided information and images on the siting of the proposed fence to the rear of the property boundary. The fence is to be wooden panel with a height of 1.8m.

Planners Appraisal: The further information received in relation to item 1 was assessed by the Planning Authority, who subsequently are satisfied with the response. The proposed installation of a new backyard fence complies with Class 5 of Schedule 2 — Exempted Development, Part I of the Planning and Development Regulations 2001 (as amended):

2. The applicant has stated an intention to redevelop the garage. The applicant is therefore required to provide greater clarification and details of the work that is included in redeveloping the garage. In the event that the garage is to be repaired photos of the garage are sufficient. In the event that the garage is to be rebuilt or extended a full set of plans, elevations and a site layout plan are required.

Applicants Response: The applicant has provided information stating the garage is to be repaired due to issues such as leaking. The garage will not be rebuilt or extended. Images have been provided by the applicant of the garage to be repaired.

Planners Appraisal: The further information received in relation to item 2 was assessed by the Planning Authority, who subsequently are satisfied with the response.

2. Appropriate Assessment

A screening exercise for an appropriate assessment has been carried out and it is concluded that the development is unlikely to have significant effects on any European sites. Please see attached report under Appendix A.

3. Evaluation

I consider that the proposed development complies with Section 4 (1)(h), (2)(a) of the Planning and Development Act 2000 (as amended) and Classes 3, 5 and 12 of Schedule 2 – Exempted Development, Part I of the Planning and Development Regulations 2001 (as amended): and is thereby considered to constitute exempted development.

4. Conclusion

- Section 2, 3(1), 4(1)(h) 4(2)(a)(i) of the Planning & Development Act 2000, as amended.
- Article 6 and Class 3, 5, 12 Part 1 of Schedule 2 of the Planning and Development Regulations 2001 (as amended).

It is considered that the proposed works including removal and replacement of rainwater pipes and gutters, windows, window sills, two entrance doors, installation of new backyard fence, painting, retiling, garage redevelopment and internal works at 22 Churchview, Edenderry, Co. Offaly, R45 Y364 is **development** as defined in Section 3(1) of the Planning and Development Act 2000 (as amended) and **is exempted development** as defined by the Planning and Development Act 2000 (as amended) and the Planning and Development Regulations 2001 (as amended).
