## Forward Planning Residential Zoned Land Tax

The Council's final RZLT map for 2024 was finalised and published on the Council's website on 1 December 2023. The Residential Zoned Land Tax (RZLT) was announced in Central Government's Budget 2022 and was introduced into Part 22A of the Taxes Consolidation Act 1997 by the Finance Act 2021. The principal purpose of the RZLT is to encourage the timely activation of zoned and serviced residential development land for housing.

#### **Just Transition**

The Secretariat for Technical Assistance for Regions in Transition (START) and Offaly County Council agreed a Service Level Agreement and Workplan for the provision of 72 days of Technical Assistance to Offaly.

Following on from a site visit by the START team in March 2023 and a review meeting in June, the first of two planned one day workshops took place on 13th September 2023. A second workshop took place on 27th November 2023 with a view to devising a mechanism which will support the development of a new partnership in vocational / tertiary education, training, and research to promote a local just transition. The draft final report from the START team recently issued in December 2023. It will be finalised in January 2024.

## Local and Regional Economic Support Strategies Support Scheme

The above-mentioned scheme was launched on **13 October 2023**, to be administered by Pobal. This scheme will see the disbursement of €24m for projects aligned to Local Economic and Community Plans and the disbursement of €5m for projects aligned to Regional Enterprise Plans.

- LA led LECP aligned project applications Offaly County Council applied for funding for an Economic Development Unit to support the objectives of the Local **Economic and Community Plan** Offalv **Economic** the **Development Strategy and Action** Plan 2022-2027. The closing date was 8th December 2023.
- LECP aligned projects Offaly County Council submitted 5 Concept Papers by 17<sup>th</sup> November 2023. Feedback has been received which will inform the full applications, which are due by 23<sup>rd</sup> January 2024.

#### **Failte Ireland**

Offaly County Council and Failte Ireland recently signed a Strategic Partnership Agreement which will facilitate:

(a) The post of **Tourism Activator**. A three-year contract position Offaly County Council which will be 100% funded by Failte Ireland. This person will engage directly with private tourism operators within the county. This post will be filled on **2 January 2024**.

(b) Offaly County Council has been invited to submit applications directly to Failte Ireland in respect of tourism projects in the county. The closing date is 29 February 2024.

#### **Housing Update**

- There are 523 on the Social Housing Support List at the end of December 2023.
- A further 606 active tenancies are currently being supported under the Housing Assistance Payments (HAP) Scheme, 13 signed up for HAP and 2 exited from HAP in December.
- At the end of December, 35 single people and 15 couples and families were being supported in emergency accommodation.
- A rent review of Social Leasing Scheme Tenants (including Rental Accommodation, Short Term Leasing, Repair & Lease and

Mortgage to Rent) and HAP Tenants has commenced. Rent assessment forms and cover letters will issue to tenants from 17th January and tenants are requested to return completed forms and supporting documentation to the Housing Section by 6th February 2024. ## **Housing Adaptation Grants for Older People and People**

2023 Housing Adaption Grant claims submitted to the Department. Housing continue to work with successful applicants to collate the required documentation in order that claims can be processed.

#### **Disabled Persons Grants 2023**

Housing, working with contractors, sought to maximise Disabled Persons Grants claims for 2023. The process of selecting applicants for the 2024 programme is underway, with procurement of contractors being held.

#### **Retrofit Programme**

In deciding on a works programme, local authorities are urged to choose a mix of properties across a range of BERs to allow for homes which need significant expenditure to be balanced out by those needing lesser spend so as to achieve the overall average cost of €34,000 per property. A BER rating of B2 must be achieved.

### **Community Culture and Emergency Services**

### Local Community Development Committee

Offaly LCDC held their monthly meeting on Thursday December 14<sup>th</sup>. Main agenda items included the Rural Development LEADER Programme 2014 – 2020 & Transitional LEADER Programme 2021 – 2022 and Social Inclusion Community Activation Programme 2018-2023 (SICAP).

#### **LEADER Projects**

Three LEADER Projects were approved to the value of €69,762.81

The Local Development Strategy (LDS) submitted by Offaly Local Community Development Committee in respect of its interest in delivering the 2023-2027 LEADER programme in the Offaly subregional area was not selected by The Independent Selection Committee.

#### **SICAP**

Members were informed that the tender competition and evaluation process for the new SICAP programme 2024 - 2028 is now complete and the Offaly Local Development Company (OLDC) were congratulated on their successful tender.

#### **Community Support Fund**

Ministerial approval was received on the 21st June 2023 for funding totalling €283,843 to be awarded to 188 successful community groups. The Community Support Fund supports community groups with either their Operating/Running Costs such as utility bills, insurance, etc., or capital costs which aim to enhance facilities or purchase equipment. To date 183 groups have been paid their grants amounting to €279,743. The remaining groups must submit outstanding paperwork prior to payment of the remaining €4,100.

#### **Community Recognition Fund**

Final approval for the 26 successful projects amounting to €636,206 was received from DRCD on 22<sup>nd</sup> May 2023. Funding Agreements have been agreed between OCC and the successful applicants. All projects must be completed by 18 October 2024. Seven of the projects were fully completed in 2023, and 9 partly completed in 2023. Funding totaling €301,564.89 has been drawn down to date. Eleven projects will be fully completed in 2024.

#### **Local Enhancement Programme 2024**

The Local Enhancement Programme 2024 was announced on 6th December 2023, by Minister for Rural and Community Development, Heather Humphreys TD, and Minister of State with responsibility for Community Development and Charities, Joe O'Brien TD. Details of the operation of the scheme were received from DRCD on Wednesday 13th December 2023. The Programme will open for applications from Friday 19th January 2024, with a closing date of Wednesday 28th February 2024. Community and voluntary groups will be eligible to apply for funding to carry out minor capital works and improvements to their facilities, and to purchase equipment for community use. An allocation of €162,599.36 was announced for Offaly see breakdown below.

The fund will replace the Department's Community Enhancement Programme (CEP) and will be administered by the Offaly Local Community Development Committee (LCDC). Funding of €27,099.89

has been ring-fenced to support Women's Sheds, Groups and Networks in Offaly.

"The PPN was busy following up on the outcomes from the Plenary

in November.

The PPN submitted an application for Leader Environment funds and were successful in securing a fund to deliver on the Community Energy Charter in 2024 through the LCDC.

The Secretariat and reps had an end of year meeting on Dec 14<sup>th</sup>. This included setting a date for the Workplan day which will take place on Jan 17<sup>th</sup> 2024. Plans are also underway for the Midlands Regional PPN Meeting in late January. Offaly are hosting the meeting on this occasion.

PPN Reps contributed to the Community, Culture & Emergency Services SPC and also the JPC meetings in December.

A presentation was made to the LCDC members on the role and actions of the PPN in 2023 at the December LCDC meeting. This was very well received with the number of PPN groups at 642 being noted.

The PPN Secretariat was represented at the Community & Voluntary awards event, on Saturday 16<sup>th</sup> December hosted by the Volunteer Centre in conjunction with OLDC.

The final major event of the year was the roll out of the Climate Action Community

fund. On the evening of December 18<sup>th</sup>, the PPN in conjunction with the Climate Action Team held an online information event to ascertain the level of interest and the challenges groups might face in applying for the funds.

This event will inform the Climate Action Team of the type of supports that will be required in 2024 to assist groups in making applications. The PPN will contribute to this process.





#### Comhairle Na nÓg



A member's meeting was held. Committee Roles were explained to

new members and discussed. Roles will be voted on in January 2024. Staff from Offaly Library service attended the meeting to consult with the group on their

development plan, members completed a survey.



Comhairle members presented at the Community, Culture and Emergency Services SPC Meeting. The presentation outlined the purpose of Comhairle na nÓg and covered their work and achievements in 2023.



#### **ARTS**

#### Arts Strategy 2024-2028



The development of the new strategy has developed

through a phased approach of research, consultation and writing throughout 2023. The writing phase is now in draft stage and the report was submitted for review by the Community and Culture SPC in December – following feedback from the SPC the aim will be to submit to the council early in 2024 for approval.

### ARTS OFFICE PROGRAMMES

**Lough Boora - Art in Landscape Project Funding** 

Planning for the Art in the Landscape Festival of Change, taking place in Offaly



and Mayo in April 2024 is currently ongoing with calls to artists and communities being

released before the end of the year. As part of the Art in Landscape: Festival of Change there will be an event called Tionól – a gathering of ideas; a creative space to share ideas and an opportunity for participants to share their 'big' or 'small' ideas around Art in the Landscape. The purpose of the event is to share ideas and spark conversations locally.

A call has been issued to anyone interested in, working in or volunteering in arts, heritage, culture, tourism, community development, the environment economic development or a local community member living near Lough Boora Sculpture Park, to submit their ideas to share as part of the event. Ideas will be shortlisted based on having a mix of ideas from different sectors at the event. Selected presenters will have presentation slots of 10 minutes each.

#### **FilmOffaly**

The FilmOffaly Award 2023 has been awarded and the Arts Office are delighted to announce the winning script *A Simple Killing* by Mark Conway. This film will be produced in Offaly in 2024 by the production team, Jason Branagan, (Director) Mark de Carreau, (Actor, Producer) Emer Durcan (Producer) and Brian Durcan (Cinematographer) of Western Front Studios.

#### FilmOffaly Review

The FilmOffaly Review undertaken by researchers, *Culture Works* across the Summer months has been completed. The report has been presented to the Community and Culture SPC , FilmOffaly board and the Management of Offaly County Council. Following these presentations recommendations and actions will form part of the new Arts Strategy 2024-2028.

#### **Annual Programme**


#### **Hullabaloo! Offaly Children's Arts Festival**

This was a much broader offering this year also, with the inclusion of Esker Arts as a partner in the festival this year. The programme was launched September with inclusion from artists from all over Ireland delivering workshops and performances in several art forms for children up to 12 years of age. This was the 17<sup>th</sup> edition of Hullabaloo! and it was the largest festival to date with a record 101 events taking



place across venues in four towns in Offaly from November 1<sup>st</sup> to November 4<sup>th</sup> showcasing an eclectic blend of artforms and experiences for children and their families to enjoy. In Birr, Clara, Edenderry and Tullamore there were 1,381 in attendance at the festival.

#### **Creative Places Edenderry**



Creative Places, Edenderry, a project funded by the Arts Council, led by Creative Lives in partnership with Offaly County Council Arts Office and Edenderry Municipal District, has had a dynamic 2023!, with an array of different arts-based workshops activities, and throughout the year. These have included: Visual Arts, Music, Poetry, Playwriting, Screenwriting and Creative Writing; a Lego Clinic: Creative Movement; Dance: Ceramics; Drama; Radio, Photography and more. Towards the end of the year, the project saw a more collaborative way of working emerge with different groups across the Community coming together to respond to the ethos of the project. For example, the ASD Friends for Life group, The Parkview Residents Association, The Rainbow Room - parents group at St. Patrick's Primary School, Edenderry Library and more. Creative Places, Edenderry funded six Creative Grants of €500 each in the Community and three Artist Commissions ranging from €4500 €12,000. Seonaid Murray, Creative Places Edenderry Co-ordinator has said 'I am most proud of the growth in confidence within the Community and witnessing the realisation that this really is an all-inclusive project where all Creative ideas are welcome and supported in a safe, positive environment.'

#### **CAPITAL PROJECTS**

#### **Esker Arts**

The Offaly Artists Show, an exhibition featuring work by visual artists from or living in the county was on show in the venue for the last two months of the year. In all, it was a successful first year for Esker Arts and it augers well for the future, and

the important role that the venue will occupy for the arts in the county.

#### **Edenderry Library and Arts Base**

The Arts Office continues to work in close collaboration with the county librarian in the development of plans for a Multi-Purpose Arts space and Artist's Studio's to be incorporated into the planning of the new library for Edenderry, this include the audience and participant development as part of the Creative Places Edenderry project.

#### **HEALTHY OFFALY**



In December year 1 of the multiannual Healthy Ireland Fund Round 4 concluded. Work began on formulating

and distributing reporting templates for implementing partners to input details of the project spends and progress in rolling out their actions. All partners were given a deadline of 19<sup>th</sup> January 2024 to have submitted their financial and progress reports to Healthy Offaly.

As projects finished up for 2023 all partners were asked to submit their action evaluation questionnaires to Edufit who were commissioned to examine and report on action results. Edufit will conduct a detailed review of the levels of pre and post action physical activity and obesity among the participants. This report will be presented to the February LCDC Meeting. The report will inform us on year 1 actions. It is hoped to continue most of year 1 actions into 2024 with new projects identified for inclusion next year. They are:

1. An Offaly Healthy Libraries initiative called 'Minding Me' a 6-week nutrition, exercise and health education programme for retired individuals in Offaly. The

programme content suggested is in line with the Obesity/ Healthy Eating outcome indicator and will be delivered on site in Tullamore Library.

- 2. A Bord Na Mona's 'Cycling without Age' project whereby rickshaw bicycle operated by a trained volunteer has been purchased for Lough Boora Discovery park to allow those with additional needs access the parklands in a safe and inclusive manner. Healthy Offaly have been petitioned for funding for an online booking system which will schedule and manage bike bookings.
- 3. A Healthy Laois/Healthy Offaly joint venture to purchase sets of activator poles for Portarlington Library. The poles will be loaned on the main library booking system to those looking to get out and active and who previously may not have access to such fitness aides.

The girls concluded the programme with a fun trip Ice Skating in Blanchardstown on Thursday 14<sup>th</sup> of December.

### 'Michael Flanagan: 50 Years Referee' Photography Exhibition in Tullamore Library


Wordsmiths presented the launch of an exhibition titled 'Michael Flanagan: 50 Years Referee' in Tullamore Library on Thursday 4th January.

## Climate Action Local Authority Climate Action Plan

**Under the Climate** Action and Low Carbon Development (Amendment) Act 2021 Section 12B (2) each local authority is required to prepare a local authority climate action plan for its



respective administrative area. The guidelines have been issued under the provisions of the Act and are therefore statutory in nature.

Offaly County Council have developed our draft Climate Action Plan 2024-2029 for adoption by Reserve Function before 23rd February 2024.

The submissions received for the draft Climate Action Plan are currently being considered before the plan is submitted to the Members for their approval.

#### **Community Climate Action Fund**

The Community Climate Action Fund (CCAF) was launched within Offaly on 13<sup>th</sup> December 2023, and will remain open for application for 12 weeks, until 6<sup>th</sup> March 2024.

The Community Climate Action Programme, under the Climate Action Fund, has been developed under two strands addressing both direct climate action, and climate education and capacity building.

Strand 1 has two parts: strand 1 entitled "Action: Building Low Carbon Communities" for €24 million, and strand 1a entitled "Shared Island Community Climate Action" for €3 million.

## Strand 1: Action: Building Low Carbon Communities

€444,000 is being provided to Offaly Co. Co. to work in partnership with communities, large and small, rural and urban, within their areas of operation to build low carbon communities in a considered and structured way. The projects will address the following five themes:

- Home/energy
- Travel
- Food and waste
- Shopping and recycling
- Local climate and environmental action

### Strand 1A: Shared Island Community Climate Action

In addition, a total of €3 million is being provided by the Government's Shared Island Fund to support cross-border and all-island community climate action initiatives as an integrated part of the Community Climate Action Programme. Strand 1a enables communities and LAs to propose a cross-border project in partnership with organisations in Northern Ireland. The themes are the same as strand 1.

Offaly County Council is hoping to receive applications to avail of the €444,000 allocated for community groups in Strand 1. Suitable projects will receive 100% funding and must be completed within 18

months of the signed grant agreement (between OCC and relevant community group). The Community Climate Action Officer will co-ordinate this fund within Offaly Co. Co. Expressions of interest will be through an on-line application form available on www.Offaly.ie

#### **Energy**

Offaly County Council Energy Action Team launched their "Energize Offaly" campaign aimed at raising awareness amongst staff and elected members of the work done to date to increase energy efficiency across the organization and promote further action to help achieve statutory targets. Offaly County Council have again signed up to the SEAI "Reduce Your Use" for 2024, which aims to reduce unnecessary energy consumption across the public sector.



#### **Environmental Management**

From January to end of November, the Environment Section received 998 environmental complaints. All were investigated in a timely manner and resolved where possible.

#### **Environment Complaints**

Offaly County Councils website has been updated to include an online environmental complaint form. This means that it is easier for members of the public to register a complaint. Environments Complaints Handling procedure has also been amended.

#### **Litter Management**

Following the positive feedback from the offices regarding the compaction litter bins, Environment applied for and was approved for funding for additional bins under the Anti-Dumping Initiative. This allowed the Council to increase the quantity of bins across the county to 15. The bins can hold up to 8 times more litter than a conventional litter and allow for more efficient streamlining of the Council's Street cleansing services. Bins were installed in the following locations:

- ✓ Heritage Centre, Ferbane & Emmet Square, Birr & Market Square, Birr & Clara Square
- ✓ Tullamore Millenium Plaza & St. Kyron Street & O'Connor Square
- ✓ Edenderry JKL Street. & Town Hall, Medical Hall & Main Street
- ✓ Mountbolus Park
- ✓ Harbour Road, Banagher
- ✓ Crinkle Village and Cloneygowan Village



An additional benefit is that the bins have advertising panels on each side, which allow for environmental

messages and themes to be exhibited. Environment has taken the opportunity to promote the Council's Climate Strategy to raise awareness among the public. These

panels can be changed to allow for any environmental theme to be advertised.

#### **Environmental Awareness**

The Environment Department participated in a pilot programme "Composting for Schools". Four schools who expressed an interest in composting were selected to work with Composting Ireland. The programme consisted of workshop training for teachers and community members, onsite training on how to compost, develop wormeries and manage organic waste within the school. The schools who are participating are: Scoil Naomh Mhuire, Cloneygowan, St. Mary's NS, Pullough, Scoil na Croise Naofa, Geashill and St. Josephs NS, Arden, Tullamore. So far, the feedback has been very positive, and it is hoped to extend this programme in the coming year to more schools.

# **Burial Grounds St. Mary's Cemetery, Edenderry**

The tender documents for the construction of the extension to St. Mary's are being prepared and it is planned to publish the tender by the end of January 2024.



#### **Cemetery Committee Grants**

This year we have supported seventeen cemetery committees with grants for the upkeep and enhancement of their local cemeteries, and specific projects or purchases for the upkeep of the cemetery. The overall standard of work carried out by these volunteer groups continues to be

very high and we will continue supporting these groups in 2024, and we look forward to working with new committees in 2024.

## RURAL WATER SERVICES Subsidies

The 2023 GWS annual subsidy was paid to the 15 no. Private and Public Group Water Schemes, amounting to €1,072,067.00



#### Capital

The Rural Water Unit of the Department of Housing have advised that the next Multi-Annual Rural Water Programme capital funding scheme will be announced imminently. Under the most recent programme over €2m of funding was secured for 24 separate projects ranging from public health measures to amalgamation of group water schemes.

#### **Domestic Lead Remediation Grants**

The Domestic Lead Remediation Grant Scheme has been in existence since 2016 and the Department of Housing, Local Government and Heritage have revised the eligibility criteria with effect from 1 December 2022.

Lead is a naturally occurring metal that was used for pipework and plumbing in some houses built up to, and including, the 1970s. However, exposure to lead in drinking water has been identified as a serious public health risk. The grant scheme was introduced in line with the Government's National Lead Strategy in order to reduce people's exposure to lead in drinking water.

The aim of the grant is to assist households with the cost of replacing lead pipes and fittings within the boundaries of the property. The grant is available if you receive a water supply from either a public or private water supplier.

According to the World Health Organisation, there is no completely safe level of lead in drinking water. The best and most effective way of dealing with lead in drinking water is to replace all lead pipes and all lead plumbing delivering drinking water to the house concerned.

The new eligibility conditions in the revised grant include:

- Removal of the means test requirement;
- Introduction of a uniform grant rate of 100% of the eligible costs of the replacement of any such lead pipes and/or related fittings, or €5,000, whichever is the lower;
- An additional eligible cost can be claimed to a maximum of €200 for the provision of a certificate from a laboratory or notification from a registered building professional, as outlined at (b) and (c) above and provided for in Regulation 5(1)(b) and 5(1)(c). This cost is to be included in the calculation of the maximum eligible cost total of €5,000. Note, any indirect costs incurred by the applicant themselves are not eligible costs;
- The house concerned must be occupied by the applicant as their normal place of residence;
- Minimum expenditure on eligible works in order to qualify for a grant has been increased from €200 to €750.

#### **Domestic Waste Water Treatment**

The DWWTS grant scheme will be amended from 01/01/2024, removing the requirement for the septic tank to be registered and also increasing the grant to 85% of allowable costs up to a maximum of €12,000.00

Grants for a Septic Tank or Domestic Waste Water Treatment System (DWWTS), to assist with the costs of remediation, repair or upgrading works to, or replacement of, such DWWTS are only available from a Local Authority where a septic tank has been

inspected by the Local Authority or Local Authority Waters Programme Office (LAWPRO) under one of the following inspections regimes:

- National Inspection Plan
- Prioritised Areas for Action, as outlined in the River Basin Management Plan, and remediation, repair or upgrading works or replacement of the DWWTS is recommend after inspection by the Local Authority.
- Where a dwelling is in a High Status
   Objective Catchment Area, and
   remediation, repair or upgrading
   works or replacement of the
   DWWTS are recommend after
   inspection by the Local Authority.

If persons have been recommended remediation, repair or upgrading works or replacement of your DWWTS as per above then they may be entitled to a grant towards the works required and the application form for the DWWTS grant will be provided to you by Offaly County Council.

#### **Well Grants**

Grants are available from Offaly County Council to assist with the improvement of a water supply to an individual private dwelling (this means a water supply providing water intended for human consumption and domestic purposes that serves only one house).

The key features of the scheme are:

- The grant payable for rehabilitation works is 85% of approved costs subject to a maximum of €3,000.00, where the Local Authority agrees that this is the most appropriate solution.
- The grant payable for the provision of a new well is 85% of approved costs subject to a maximum of €5,000.00, where the Local Authority agrees that this is the most appropriate solution.
- The provision of a water quality treatment system (typically filtration and Ultra Violet treatment) qualifies for 100% funding up to a maximum of €1,000.00, where the Local Authority agrees that this is the most appropriate solution. This can be claimed on its own or in addition either the grant rehabilitation works or the grant for a new well. This does not include water softeners in hard water areas.
- The minimum grant threshold is €750.00

Please note that this scheme does not apply to houses to which a Public Water Supply or a Group Water Scheme has already been provided or can reasonably be provided.

In 2023 we assisted 15 households with grants under this scheme totalling €65,549.95.

## Veterinary Control of Dogs

In 2023 months we have cared for 289 dogs in the Dog Shelter which is an approximately 6% increase on the previous 12 months.

On average 15% of the dogs are reclaimed by their owners, 15% are rehomed by the Care of Dogs Team and the other 70% are rehomed through animal rescue charities. The Control of Dogs team has also dealt with 73 complaints since the start of the year and brought 2 successful prosecutions through the courts in 2023.

#### **Control of Horses**

We have dealt with 21 complaints under Control of Horse legislation from January to August 2023, which resulted in the seizure of 11 horses and donkeys.

#### **Veterinary Inspections**

Offaly County Council continues to operate the Shared Service Agreement for Veterinary Services in the Westmeath County Council administrative area.

#### **TRANSPORTATION**

#### **Public Lighting**

The following is a breakdown of the Public Lighting failures across the County. There are 217 faults on the system presently. 39 of these faults require third party intervention and as such cannot be repaired by the maintenance contractor. There are also 23 of the 39 third party faults that are historical records that include private housing estates whereby a survey was uploaded regarding a public lighting asset that was commissioned in the first instance hence cannot be a fault. These anomalies are being addressed by the yearly public lighting capital program.

Therefore, the current actionable faults amount to 178 faults or 1.91% of the lighting stock.

The breakdown of the 178 faults across each MD are as follows:

### **Corporate Fleet Management**

Five new electric Vehicles have been deployed within our Corporate Fleet in December as part of the Roads and Infrastructure commitment to decarbonising the corporate fleet via the application of Zero and Low Emission full options.

### Ballycommon Trailhead/Grand Cana Greenway

Approval to proceed to tender for the proposed new parking facilities at Ballycommon was received from the TII in December 2023. The proposed scheme includes for 53 carparking spaces including EV charging and accessible parking, associated public lighting and traffic control measures on Ballycommon Bridge. This scheme is designed to provide a safe sustainable access point onto the Grand Canal Greenway.

#### Winter Service Plan 2023/2024

Our winter Service Plan commenced in October 2023. This service is managed by the Roads Department and the service is delivered from the Tullamore Machinery Yard and Birr Depot. There are 4 duty Engineers rostered across the season who asses real time data from the Road Networks in order to establish whether treatment is required and the associated rate of spread of rock salt.
