#### SPORTS FUNDING

The Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media announced the launch of its Sports Capital Programme scheme in December 2020. The deadline to register on the online sports capital register (OSCAR) is 5pm on Monday, 15th February; while the closing date for receipt of applications under the SCP is 5pm on Monday, 1st March 2021. Offaly Sports Partnership is hosting a "getting grant ready" webinar in February.

### REPORT AT A GLANCE

### Local Enterprise Office Ready for Customs Grant

This new grant provides companies with financial assistance to cover the costs of taking on much needed additional customs clearance staff. This is a cash limited scheme of up to €20m, with the following financial support available:

- A grant of €9,000 to support the recruitment or redeployment of a full-time1 employee into a dedicated customs role.
- A grant of €4,500 to support the recruitment or redeployment of a part-time2 employee into a dedicated customs role.

The scheme closes on 31th March 2021 or when all the funds are allocated, whichever is the earlier.

#### **Development Management**

Planning applications continued to increase during 2020 despite lockdown due to COVID-19 and related suspension of timescales on Planning Legislation, from March to May 2020. This represented an annual increase of 7% on the 2019 figures

While the annual increase in itself is significant, it does not take into account the size and complexity of the applications received throughout the past year. The Planning Department has assessed a wide range of large-scale developments

including; large residential developments, retail, commercial, industrial and mixed use developments. In addition, the Planning Department has seen a marked increase in the number of 'Green Energy' applications submitted in 2020.

Pre-planning meeting requests and in particular telephone queries have risen sharply during 2020 and has continued during the COVID19 emergency shutdown period. No site visits were permitted during the emergency shutdown period. The Planning Department has conducted in excess of 300 no. pre- planning meetings (mostly using electronic means).

With respect to planning applications received by the Planning Department in 2020, the following has been observed:

#### **Housing Developments**

The high volumes of the level of preplanning meetings undertaken has resulted in a significant increase in the number of large housing developments and schemes lodged to the Planning Department. This trend has been particularly evident with the lifting of COVID planning restrictions and the lodgement of a number of large housing schemes in Tullamore and the key urban areas across the County. In addition, there has been a marked increase in the volume of 'multiple unit housing development' planning applications submitted to the Planning Department in 2020.

Single one-off houses and small minor domestic extensions/additions planning applications etc. have remained relatively constant during 2020.

#### 'Green Energy' Applications

The Planning Department has seen a substantial increase in the volume of green energy related planning applications submitted and processed in 2020. These complex green energy projects include, but are not limited to, large-scale commercial solar farms, wind farm developments,

battery and other new technology energy storage facilities, anaerobic digestor, biomass storage facilities, large-scale greenhouse proposals and a biomass gasification plant.

### Strategic Housing Development (SHD) Applications (i.e. over 100 houses)

The first Strategic Housing Development (SHD) in County Offaly was lodged to An Bord Pleanala (ABP) in August 2020. The proposed development comprises of 358 no. residential units (172 no. houses & 186 no. apartments), childcare facility and all associated site works.

Following the submission of this SHD application to ABP, a number of internal meetings were held across the various OCC directorates, a presentation of the proposal was undertaken for the elected members at the September Meeting of the Tullamore Municipal District, and Chief Executive's report was subsequently compiled and submitted to the Board as part of the required SHD process. In November 2020, ABP refused the SHD application as it was considered the proposal presented a substandard layout and link road.

Planning administration is working in line with government guidelines with many remote working. This has required changes to service to the public.

#### **Grand Canal Greenway - 2020**

#### **Planning**

- In February 2020 non-statutory public consultation took place relating to the Grand Canal Greenway

   Turraun to Shannon Harbour. This was paused due to COVID Lockdown and resumed in June & July 2020.
- In August the Part 8 for the Grand Canal Greenway Turraun to Shannon Harbour (16.2km) was published

- In October Part 8 was approved for the Grand Canal Greenway Turraun to Shannon Harbour (16.2km)
- In November 2020 pre-design study of proposed Part 8 from Henesey's Bridge to Pollagh Bridge (circa 5km) on Northern Bank commenced. Part 8 Targeted for Q1 2021.

#### **Funding Applications**

- In December 2020- Funding from DTTAS, was announced to complete the GCG from Daingean to Edenderry (County Boundary with Kildare.)- (34km)
- Various Funding Applications are being pursued to complete elements of the GCG/ and the Midlands Cycling Destination – Offaly, as well as extensions to the GCG, under Just Transition Fund, and ORIS and Town and Village Renewal Schemes.

#### **Greenways 2021**

- 1- There was a pause in construction at of Grand Canal Greenway Ballycommon Daingean and Pollagh to Turraun, due to inclement weather & COVID Restrictions and construction is due to recommence in Q1 2021.
- 2- Preparation of Part 8 from Heneseys Bridge to Pollagh Bridge on the Northern Towpath will commence as soon as COVID restrictions allow, subject to agreement with Waterways Ireland.
- 3- Works on 3.5km between Wood of O Bridge and County Boundary (Kilbeggan Link) are due to commence in Q1 2021. This is funded by ORIS 2019.

#### Slieve Bloom Mountain Bike (MTB) Trails

During 2020, construction of the Slieve Bloom Mountain Bikes Trail continued in

both counties Laois and Offaly. A funding application coordinated by Coillte, has received funding under the Rural Regeneration **Development** Fund **programme** to complete the trail system. The development will give a major tourism boost to the area and it is hoped that it will see the village of Kinnitty emerging as a successful hub for services such as bike hire, showers, bike wash, food and accommodation in addition to its existing prominence as a meeting / starting point for the many walks and road cycling routes in the mountains. Offaly County Council submitted an application for a cycle / walkway link between the trails and the village of Kinnitty under the **Outdoor** Recreation **Infrastructure** Scheme (ORIS) 2019. This was unsuccessful, however the link remains a priority, particularly as more trails open in the years ahead.

#### **Forward Planning**

The draft Offaly County Development Plan 2021-2027 was prepared during 2020 and placed on public display from 27th July 2020 to 7th October 2020 inclusive during which 196 written submissions and observations were received by the Planning Authority for consideration in the making of the final Plan, after which the preparation of a CE Report on the submissions commenced.

The covid timeline freeze introduced by the Covid 19 emergency legislation and associated circulars resulted in a delay to the progression of the draft Co. Development Plan.

#### REGENERATION

A presentation on the funding streams for regeneration projects is listed on the Agenda for the Monthly Meeting of the Council in February.

# Announcements pending Urban Regeneration Development Fund: (RRDF)

The Department of Housing, Planning and Local Government announced a call for URDF funding in 2020. A comprehensive application for Tullamore town consisting of a suite of urban regeneration projects were submitted on the May 29<sup>th</sup> 2020. An announcement of National successful projects is due in Q1 2021.

## **Rural Regeneration Development Fund:** (RRDF)

#### Rural Regeneration Category 1:

The Department of Rural and Community Development announced a call for RRDF Cat 1 2020 funding in June 2020. 2 applications were submitted by Regeneration Team in conjunction with other relevant sections on 1<sup>st</sup> December 2020. An announcement of National successful projects is due in Q1 2021.

## Outdoor Recreational Infrastructure Scheme: (ORIS)

The Department of Rural and Community Development announced a call for ORIS 2020 funding on 29<sup>th</sup> May 2020. 2 applications were submitted by Regeneration Team in conjunction with other relevant

#### ROADS

Roads Programme 2021: In line with Public Health Measures to prevent the spread of COVID-19 road works are currently restricted to essential services: repair/construction of critical road and utility infrastructure. The service has continued with minimum disruption and planning, design and procurement of schemes for 2021 have progressed as normal.

Offaly County Council received the 2021 National Roads Allocation of €2,300,855 from the TII and we are awaiting the grant allocation for the Regional and Local roads in the County. The 2021 Roads Programme will be prepared for March 2021.

The National Transport Authority (NTA) has developed a five year walking and cycling infrastructure delivery plan to progress the Government's commitment of €1.8bn toward the development of active travel over the next 5 years. The Roads section and MDs are currently engaging with the NTA to deliver active travel projects in Offaly in 2021.

#### **ENVIRONMENT AND WATER SERVICES**

Reports of EWS works in each of the individual Municipal Districts, Birr, Edenderry and Tullamore were delivered to each of the Municipal districts in February 2021.

#### **Climate Change**

Climate Change is continuing to be embedded in the day to day working of each section of Offaly County Council. The Climate Action Steering Group met on Friday 29<sup>th</sup>. This group has representatives from each section within the Local Authority. Each member reports on the progress of the goals set out under the Climate Change Adaptation Strategy. To date over 52 % of the projects/goals set out in the Offaly Climate Change Strategy adopted in late 2019, are at various stages of progression. Climate Action Leadership Training will be delivered to elected members and senior staff on the morning on the 12 February 2021, and training will be delivered to all staff during the year.

#### **Water Services - Water**

Works on the upgrade of the Tullamore, Birr and Clonaslee Water Treatment plants are on-going. Find and fix works are ongoing in Rhode, Tullamore, Newtown, Edenderry and will commence in Clara. Disinfection programme is nearing completion at Toberdaly, Coolderry, Clonbullogue, Edenderry and Walsh Island.

#### Wastewater

The design for the upgrade and expansion of Edenderry WWTP is ongoing. Design Works are also commenced for Rhode, Walsh Island, Rahan, Kilcormac, and Daingean Wastewater Treatment Plants.

A number of remedial works were completed this month in Tullamore, which should improve the quality of the receiving waters—including, Tara Street, St Brigids Place and Bachelors Walk—Lidl

## **Environment - Litter & Waste Management**

Tullamore came 4<sup>th</sup> out of 37 towns / cities surveyed in the recent IBAL survey and was deemed "Cleaner than European Norms"—status. Six out of the ten sites surveyed received the top litter grade and there were no seriously littered sites. Topranking sites in Tullamore included Market Square, the waterside environment at Bury Quay and Lloyd Town Park – the latter was exceptionally well presented and maintained, a wonderful town park environment.

EWS received and investigated 87 litter and waste complaints to date for 2021, of which 65 complaints have been resolved. Dog fouling is becoming an issue and we have started a social media awareness campaign advising the public to clean up after their dogs. EWS continues to support schools in their green schools and work with An Taisce in trying to deliver the Green Schools Programme in an effective manner remotely. In relation to the Community Action Fund, the deadline for the 2019/2020 projects has been extended by

the DCCAE until June 2021. E&WS has completed the vast majority of projects and will have completed—all projects by the deadline.

#### Water Quality River Basin Management Plan - Cycle 3 Characterisation


A review of all waterbodies (rivers) has been completed by the EPA, and the Environment & Water Services Section have made submissions for Offaly's waterbodies. This will be incorporated in the next *Draft River Basin Management Plan 2022-2027* which will also be open for public consultation in 2021, and all Councillors will be notified.

The Water Framework Directive sets a target of achieving at least Good Status in all waterbodies by 2027. Offaly County Council have a dual role under the Water Framework Directive –

- 1. To protect rivers that are Good and High Status and
- 2. Improve rivers that are at Moderate and Poor Status.

The summary slide below shows the status of rivers across the county, with the most recent data from 2013-2018 at the bottom, and the colour codes for each status under the title. The key trends are worth highlighting with an 8% decline in Good Status rivers, and a 10% increase in Poor Status in Co. Offaly recent years.

#### **Rural Water Programme**

The Multi-Annual Rural Water Programme 2019 – 2021 is ongoing. Of the 19 projects across the county that were approved for grant funding for capital projects under MARWP 19-20, 7 have been completed to date and the other 12 projects are at various stages of planning and construction. More than €1.85m was allocated to Group Water Schemes in Co. Offaly under the MARWP 2019-2021 and so far €568,166.35 has been paid to GWSs for the works already carried out.

Annual subsidies for Group Water Schemes have been completed, a total of €978,426.00 was paid to schemes across the county. Our subsidy payments process was audited internally in 2020 and was found to provide 'Satisfactory Assurance' that it is in compliance with the Public Spending Code. Water quality sampling of Group Water Schemes has continued during the year with the Groups Schemes helpfully providing sampling kiosks and access to outside taps to assist with sampling during Covid-19 related restrictions.

#### **Burial Grounds**

The tender documents for the extension of Kilreaghan Cemetery in Ferbane are due to be issued in Q1 2021 and Offaly County Council are in consultation with the local cemetery committee to include their views on the project. The proposed extension to Kilcoursey Cemetery in Clara was adopted under Part 8 of the Planning and Development Regs, 2001 and will proceed to tender in 2021.

#### HOUSING

#### Covid 19 – Housing

The Housing Section continued to provide critical essential services as outlined in the Government Roadmap during the Covid-19 level 5 restrictions. To assist us in

#### **January Housing Update**

- There are 518 on the Social Housing List awaiting housing support at the end of January 2021.
- A further 859 active tenancies are currently being supported under the Housing Assistance Payments (HAP) Scheme, 8 signed up for HAP and 5 exited from HAP in January.
- At the end of January 2021 there were 18 single people and 6 families in emergency accommodation.
- 2 Rebuilding Ireland Home Loans applications have been received in 2021 to date and are currently being assessed.

## Housing Stock – Number, Maintenance & Repair

- Total housing stock at end of January, 2021 is 1,924.
- 276 maintenance call were logged to 31<sup>st</sup> January. In accordance with current Covid-19 restrictions only emergency repairs are currently being responded to.

#### **Housing Capital Programme Update**

- Raheen, Clara development (38 units) received Stage 2 approval on 21st August 2020. It is currently at public consultation phase of the Part 8 planning process, closing date for submissions is 11<sup>th</sup> March 2021.
- Dargan Drive, Chancery Lane (20 Units) received Stage 1 approval in March 2020. The Design Team have been appointed and initial meeting held. Site investigations contractor has been procured but works cannot commence during the current Covid-19 level 5 restrictions.
- Moneygall (4 units) received Stage 2 approval in July 2020 and the members approved the Part 8 planning at the October Council meeting. Stage 3 application (permission to proceed to Tender) will be submitted to the Department in Quarter 1, 2021.
- Beechgrove Belmont (7 units) received Stage 2 approval in July 2020 and the members approved the Part 8 planning at the November Council meeting. Stage 3 application will be submitted to the Department in Quarter 1, 2021
- Sr. Senan, Edenderry (4 Units) received Stage 2 approval in August 2020, and Part 8 planning was approved by the Elected Members at the December Council meeting.

- Stage 3 is currently being prepared for submission and is expected to be lodged with Department in Quarter 1, 2021.
- Banagher, Kylebeg (18 Units) a second stage 3 submission was made in April 2020 and was approved by the DHPLG in May 2020. Tender documentation is almost complete and Tender will issue in Quarter 1, 2021
- Circular Road, Daingean (9 units) Stage 2 approval was received in
  December 2019 and the Part 8
  planning resolution was approved
  by the members at the September
  Council meeting. Stage 3 approval
  to proceed to Tender was lodged on
  December 17<sup>th</sup> and the scheme is
  expected to proceed to Tender in

#### **Vacant Houses Initiatives**

- 1 Newbridge Street, Birr: Refurbishment of derelict dwelling to provide retrofitted 3-bedroom dwelling. An external design team is appointed and Stage 2 departmental approval was received in October 2020. Stage 3 application is being finalised and will be submitted to the Department in February 2021.
- 4 Hillview, Holly Park, Birr: Stage

   1 application was submitted to the
   Department on 22<sup>nd</sup> December 2020
   to refurbish the existing derelict
   dwelling. Departmental decision is
   pending.
- Compulsory Purchase Orders (CPOs): Housing are progressing the CPO process in respect of 3 houses. An application for funding for their refurbishment has been submitted to the department.

#### **Approved Housing Bodies Schemes**

- Cluid Housing Association: Construction on the 26 units has stopped due to the current Covid-19 Level 5 restrictions.
- Tuath: Killane Drive, Edenderry (27 units) Deemed an essential site and completion is expected in Q1, 2021.
- Oaklee: Clonminch, Tullamore (19 units) Appointment of contractor is pending the resumption of construction activity.
- Oaklee: Kearney's Field (41 Units)
   In process of appointing a consultant.
- Sofia Housing: Stage 2 approved (39 units) at Presentation Lands, Portarlington. Stage 2 submission was made in October. Project now needs to progress to planning.
- Sofia Housing, in a joint initiative with Midlands Simon Community, acquired Clonamore Hotel in Q3, 2020. The facility will be developed as an enhanced centre for the of provision supported accommodation for homeless people. Under the terms of a landmark agreement Midlands Simon Community will operate the facility, with a team of qualified social care workers providing support on a 24/7 basis. Following refurbishment, the facility will provide professional supports for up to 17 people.

#### **Housing Grants**

In all 130 Housing Adaptation Grants for Older People; People with a Disability Scheme and Mobility Grants were approved in 2020 and staff are following up with the applicants.

#### **Disabled Person's Grants**

In anticipation of department allocation, the preparation of 2021 works is underway.

#### **Retrofit Programme**

The Council received notification on 8<sup>th</sup> September that €3.3m was being awarded to Offaly for the 'Just Transition for the Midlands Region' programme.

The Design Team have completed surveys of 36 no. houses and Tender Documents are currently being prepared and are expected to issue in January 2021. A further lot of 42 houses surveys were due to take place in January 2021 but have now been postponed owing to the current Covid situation. The balance of housing surveys was scheduled to take place in February

Prior to the retrofit works commencing in the dwellings the Council will engage further with the tenants to outline the works involved in each situation.

The consultants will determine the works that will be required, works may include the following:

• Replacement of the heating system to a new technology heating system called a "Heat Pump"

- New radiators
- Attic insulation top up
- External or internal wall insulation
- Window Replacement
- New Doors
- Improved Ventilation

The Council has advised SEAI of the locations of these units for retrofitting and SEAI will now engage with private properties located near these dwellings to offer similar works under their existing home energy grant schemes.

## Offaly Covid-19 Community Response Helpline

The Offaly Community Call Helpline has operated since 30th March 2020. It operates from 9.00am to 5.00pm, 7 days per week helping those who are vulnerable and who need help accessing essential services or a listening ear. The Helpline number for Offaly is FREEPHONE: 1800 81 81 81. A dedicated team of Community & Culture staff answer queries, with two staff working each weekend.

#### **Offaly Community Response Forum**

The interagency Community Response Forum has met 17 times since the first meeting on 30th March 2020. The role of the Forum is to lead the co-ordination of community supports and resilience, helping vulnerable members of the community or those living alone to get deliveries of groceries, medicine and fuels and to have social contact during the pandemic.

The members of the Forum are Offaly County Council, HSE, GAA, OLDC, An Garda Síochána, ALONE, SVP, An POST, Offaly PPN, Local Link, Citizens Information Service, Túsla, IFA, Offaly Traveller Movement, Kildare Volunteer Centre (covering Offaly), Civil Defence, Offaly Library Service, Family Resource Centres, and Offaly Community Services. There is excellent co-operation and sharing of useful information between all of the agencies on the Forum.

In April 2020 Offaly Community Response Forum allocated €65,553 in Covid-19 Emergency Funding from the Dept. of Rural & Community Development to 37 community groups and agencies responding to the Covid pandemic. A second Emergency Fund award of €48,694 was allocated by Offaly LCDC to 44 successful applicants. These grants will be

of great benefit to the applicants whose services have been greatly affected by the Covid pandemic.

#### **Age Friendly Strategy**

The Age Friendly Tri-County Radio "Chatters Matters" programme, & continues to provide entertainment and Information each Sunday morning on Midlands 103 between 8am to 9am, with a range of topics and local contributions to the programme. Healthy Ireland funding is supporting this initiative alongside external sponsorship. Regular meetings take place as the content of the programme come via Tri County working group production team.

Thirteen IPads/Tablets have been

purchased in partnership with Laois AF via funding from Age Friendly Ireland, to be distributed between the 2 counties.



#### **Public Participation Network**

The PPN held workshops on Committee Skills over 4 weeks' x 2 mornings and 2 evenings per week on Zoom. The training was received favourably. A three-hour Grant Application Workshop via Zoom was also undertaken with a good response and requests for a follow up on Project Budgets requested.

Information continues to be delivered from both a local and national level to membership via emails, online Newsletter and Social Media. Information is shared on any funding that may help support them during these challenging times.

Healthy Ireland / SláinteCare community resilience funding of €67,225 secured with 90% draw down. Delivery of actions underway; alongside delivery of standard Healthy Offaly actions


