Restart Grant 2020

Progress to date

Up to July 10th, a total of 455 applications had been approved for payment or paid to a value of €1.448m, with 59 further applications pending approval. This we estimate is approximately 31% of expected applications. The table below shows the grant aid paid to date by business re-opening phase.

Community and Culture

2) Offaly Covid-19 Community Response Helpline:

There were a total of **426** calls to the Helpline in the 13 weeks up to Wednesday 8th July 2020. Calls to the Helpline have significantly reduced in recent weeks due to the easing of restrictions, the awareness and access to the support services available and as people have family supports in place.

The Helpline is currently operating from 9.00am to 5.00pm, 7 days per week

- 17% of calls to date relate to **deliveries** of food, fuel or medicines
- 22% of calls relate to Medical supports or HSE issues
- 7% of calls relate to problems of social isolation
- 2% of calls relate to **Meals on Wheels** services
- 1% of calls relate to **Garda** matters
- 51% of calls relate to other general queries

3) Offaly Community Response Forum

The Forum has met 10 times up to June and will continue for the duration of the Covid 19 crisis. Councillor John Carroll joined the Forum from 25th June following his election as Cathaoirleach, and replaces outgoing Cathaoirleach Cllr Peter Ormond.

Local Enterprise Office COVID 19 Supports

Trading Online Voucher (eCommerce) Grants Available

LEO Offaly continues to experience high demand for the Trading Online Voucher scheme. The voucher is a financial incentive to small businesses to develop or enhance their ability to trade online. Under the scheme a qualifying business may apply for funding to a maximum value of €2,500 or 90% of eligible expenditure (exclusive of VAT), whichever is the lesser. Following approval of their application, a successful applicant can engage suppliers and upon completion of the work, submit a request for payment to the LEO in line with the terms and conditions of their voucher. One to one mentoring and information seminars are available online or by conference call to prospective applicants to support them in their application process and it will be a condition of applying for the vouchers that applicants participate in one of these mentoring sessions or seminars. The mentoring attendees will be informed of the purpose of the scheme and how best to use and get value from the application of the voucher. The application process for the vouchers will be a competitive process.

The vouchers are targeted at businesses with the following profile:

- Limited or no e-commerce presence;
- 10 or less employees;
- Turnover less than €2m;
- Applicant business must be trading for at least 6 months;
- Business are located in County Offaly.

Online Summer Business Training Courses

Booking is now available for a number of Online courses such as Start your Own Business Course, Digital marketing for Business, Forecasting and risk management in an uncertain world, Vat Returns and Submissions, A Beginner's Guide to Using Instagram To Market Your Business, How to plan a new website for your business, How to create marketing videos on a budget, How to create marketing videos on a budget and Marketing Strategy ReBoot Camp. There has been a good uptake and the feedback is very positive.

The types of mentoring available are Covid 19 - Remote Mentoring - Business, Finance, Banking Supports & Advice, Covid-19 Remote Mentoring on Human Resources, Covid 19 - Remote Mentoring - Business Planning, Covid 19 - Remote Mentoring - Social Media Strategy, Covid-19 Remote Mentoring on Microfinance Loans and Trading Online Voucher One to One Mentoring - Phone or Video Call

Microfinance Ireland loans

The COVID-19 Business Loan from Microfinance Ireland is a government initiative to support small businesses with less than 10 employees through the current period of uncertainty and protect job creation or sustainment in Ireland. Loans from €5,000 - €50,000 up to 3 years. First 6 months -0% Interest & Zero repayments. Reduced interest rate 4.5% APR for LEO applications.

If your business is impacted or may be impacted by COVID-19 resulting in a reduction of 15% or more in actual or projected turnover or profit, and you are having difficulty in accessing finance from commercial lending providers, the MFI COVID-19 Business Loan may be able to help your business. Local Enterprise Office Offaly will provide assistance with MFI applications.

Planning Administration

Planning Administration continued to receive Planning applications throughout the Covid-19 Planning emergency period. Timelines affected by the Covid Emergency Legislation extended many timelines to 18th July 2020 with large numbers of decisions due on the third week of July. Since the lifting of restrictions Planning Applications received are back to normal levels.

Development Management

The Development Management Planners have been continued to carry out site inspections and are assessing/undertaking: planning applications, planning compliance matters, minor pre-planning requests (via email) and planning queries (via email), which can be processed in light of the current Covid 19 restrictions and in accordance with the updated Government guidance. Processing of large volumes of new Planning Applications including biomass, grid connection, windfarms shows

the complexity of proposed development in the past month.

Forward Planning

The pre-draft Offaly County Development Plan was sent to members 10th June for their consideration. Two special meetings were organised to discuss the volumes of the proposed draft plan at the end of June and early July.

ROADS

Roads Programme 2020

The Roads Programme 2020 has commenced throughout the County. All works are proceeding with Covid safety measures in place. The following road works are currently ongoing or due to commence in the County:

- N52 Eglish & N52 Ballindown & Ballynaguilsha TII Capital Maintenance Works to commence in July;
- Tenders received for pavement overlay works for the Birr to Roscrea Road (N62) at Boveen, Glasderry Beg, Glasderry More. Construction to commence in August;
- Low Cost Safety scheme Erry Mills, Clara, in progress to be completed and lights on at the end of July;
- N80 Tullamore to Killeigh road surface improvement scheme to commence in August;
- Resurfacing on William Street is currently ongoing;
- Works on the Collins Lane junction, Arden Way and Arden View Junction to commence in July;
- Construction of TVR Scheme in Daingean to commence early August;



- Designs prepared for new bus stops and pedestrian crossing in Tullamore & Edenderry;
- Road Improvement Schemes and Surface Dressing in the County commenced in May and will continue throughout June and July;

Retexturing the road on the N52, June 2020

The process of blasting small ball bearings onto the roads increases the skidding resistance of the road surface and extends the roads life by up to 10 years.



Offaly Grand Canal Greenway

Offaly Grand Canal Greenway is under construction between Cappincur (Digby Bridge) and Ballycommon. Once complete, cyclists and walkers can enjoy the Greenway from Tullamore to Ballycommon and onwards to Ballycommon Church via the Kilbeggan Branch. Designs for extensions to Daingean



(East) and Kilbeggan (North) are ongoing with works complete by mid-2021.

N52 Tullamore to Kilbeggan Link Road

TII Major Capital scheme is in Phase 2: Option Selection. The first phase Public Consultation through the website, brochures and letter drop commenced on 15th June 2020 with the website www.n52tullamoretokilbeggan.ie going live with receipt of submissions to Monday 27th July.

CLÁR 2020 Programme

The CLÁR 2020 Programme provides funding for small scale infrastructural projects in rural areas. Completed applications under Measure 1 and 2, in the designated areas, must be submitted to the relevant Municipal Districts on or before 7th August.

Edenderry Inner Relief Road

Consulting Engineers, Tobin, for the **Edenderry Inner Relief Road** is progressing with the detailed design, preparation of contract documents and land acquisition.

Edenderry Granary Court to Fairgreen Link Road

This progressing with tendering of the works due to commence in late July on etenders.

Birr Distributor Road

Part 8 Planning will commence in July.

ENVIRONMENT AND WATER SERVICES

Water

Works on the upgrade of the Tullamore, Birr and Clonaslee Water Treatment plants recommenced on May 18th, following the suspension of works due to Covid.

IW are currently preparing the design for replacement reservoir at Clonbullogue and considering a replacement reservoir at Walsh Island.

Leak repair: Find and fix works are ongoing in Dunkerrin, Rhode and Tullamore.

Irish Water has confirmed that a National Water Conservation Order commonly referred to as a hosepipe ban has been lifted due to the extensive rain which we have had.

Environment

Civic Amenity Sites

All Civic Amenity Sites, bottle banks and Derryclure waste transfer station continue to see increased levels of usage over the past month. Visitor numbers have started to level off to previous year's averages after the very high demand seen during the peak of the Covid-19 crisis.

Illegal Dumping

An application was made to the DCCAE for funding under the Anti-Dumping Initiative to clean up some very littered areas and to provide funding for CCTV at bottle banks, Offaly County Council received €64,534. Work continues on the initiatives which were successfully funded. Some clean ups have already taken place in Clonearl and Garryhinch and one is scheduled for the Derries

Community Clean ups

There were 20 community clean ups completed in the month of June, where the Environment Section provided support and supplies to communities' groups and individuals.

Water Quality

Water Framework Directive sampling programme has recommenced again having

been suspended during the current restrictions in place for Covid-19.

Detailed submission has been returned to the EPA regarding the 3rd Cycle Characterisation of local rivers under the EPA's River Basin Management Plan, covering both the Midlands & East region and the South East region.

Tullamore Low Smoke Zone

DCCAE are currently finalising the SI and Regulations wording to cover the 13 additional towns to be covered by a Low Smoke Zone. Tullamore town and its surrounds will come under the new Regulations which is due to come into effect from September 2020. The DCCAE are preparing a press release together with digital and PDF maps showing the full extent of the Tullamore Low Smoke Zone.

Tullamore River Enhancement Project

The Part 8 process for the Tullamore River Enhancement Project is coming to a conclusion. Public consultation/submission period ended on the 4th June. CE and planning report will be presented to the elected members at their July meeting.

Rural Water Programme

The Multi-Annual Rural Water Programme 2019 – 2021 is ongoing, and the annual subsidies paid to the group water schemes have been received prior to the 30th June deadline. OCC are currently assesing these.

Domestic Water and Domestic Waste Water Grant Schemes

Under Measure 8 of the Multi-Annial Rural Water Programme 2019-2021 a revised Private Water Supply (Well Grants) and Domestic Waste Water Treatment grant scheme has been announced by the Dept of Housing, Planning and Local Government. We have been in consultation with the



Department about the new scheme and are awaiting their clarification about certain aspects of the new scheme and we intend to have the new applications and details available through our office and www.offaly.ie as soon as possible.

Well Grants

The apllication process and the level of grant payable have been revised. The main revision of the scheme is that the applicant must provide three quotes for the proposed works, the introduction of a Water Treatment Grant of up to $\[\in \] 1000.00$ and the percentage of the approved cost of works that can be claimed by the applicant has been increased from 75% or a max of $\[\in \] 2,031.58$ to 85% or $\[\in \] 5,000.00$, whichever is the lesser. There are also new grants available for Well Rehabilitation and Water Treatment Systems up to $\[\in \] 3,000.00$ and $\[\in \] 1,000.00$ respectively.

Domestic Waste Water Treatment grants

This grant may be available to householders where they have been identified by the Local Authority under various river basin and catchment area plans and they must meet specific criteria (an applicant cannot self declare for these grants). The percentage of the approved cost of works that can be claimed by the applicant has been increased from 75% to 85% or €5,000.00, whichever is the lesser.

HOUSING

June Housing Update

- There are 669 on the Housing Waiting List awaiting housing support at the end of June 2020.
- A further 849 live tenancies currently being supported under the Housing Assistance Payments (HAP) Scheme, 15 signed up for

- HAP and 9 exits from HAP in June 2020.
- At the end of June 2020 there were 20 single people and 6 families in emergency accommodation.
- 6 Rebuilding Ireland Home Loans applications were received in 2020 to date; 2 RIHL have been approved; 2 were invalid; and 2 are under consideration.

Housing Stock - Number, Maintenance & Repair

- Total housing stock at end of June 2020 is 1,901.
- 260 maintenance call logged in June 2020.

Housing Capital Programme Update

- Works recommenced on the 18 units at Chancery Lane, Tullamore on 18th May with completion due in July/August.
- An architect led Integrated Design Team has been appointed for the Raheen, Clara development. Site Investigations are ongoing and stage 2 is being prepared at present and should be ready to submit to DHPLG in July 2020.
- Offaly County Council will act as Architect with Design Team consultants who are appointed for the development of Church Street, Clara (Church St 3 Units); Beechgrove Belmont (7 units); Moneygall (4 units) & Sr. Senan, Edenderry (4 Units). investigations on all sites completed and the Stage 2 submission was issued to the department in June in relation to the Moneygall and Belmont developments. Stage 2 issued for Sr Senan on the 6th July.



- Stage 2 (permission to submit for planning) for Clara (Church Street) will be submitted to the Department in July.
- Dargan Drive, Chancery Lane (near Chancery new scheme): Consultants to be procured by Offaly County Council as part of new consultant framework for 16-20 units; OCC are acting as Architects; Stage 1 granted on the 5th March 2020. Consultant Tender have gone live on e-tenders on May 30th and are due back in July. The scheme design will progress in tandem with the tender period. The consultant framework can be used for further local authority schemes once in place.
- Banagher, Kylebeg 18 Units, a second stage 3 submission was made in April 2020. Stage 3 was approved by the DHPLG in May 2020 and the Tender documentation is being prepared and will issue in July.
- Circular Road, Daingean 9 units -Stage 2 approval was approved on the 4th December 2019 with a request to increase the number of units from 7 to 9. Part 8 is currently on public display for a period of 4 weeks starting on 30th June, 2020.
- Rectory Lands, Birr options for consideration are being developed.

Approved Housing Bodies Schemes

 Mid Offaly Housing Association: Mountbolus - 4 units are substantially completed and the AHB have informed the successful nominees when the units will be made available. Works on concluding the houses, delayed due

- to Covid 19, have resumed since the lifting of restrictions on 18th May.
- Oaklee: Clonminch, Tullamore 19 units, Stage 3 was approved on the 26th March. Tenders are due back in mid-August and works are to commence later this year.
- Oaklee: Kearney's Field 41 Units, Tenders are due back in mid-August and works are to commence later in 2020.
- AHB Killane Drive, Edenderry 27 units – Construction resumed on the 18th May with completion now due in O1 2021.
- Sofia Housing: Stage 1 approved for 32 units at Presentation Lands, Portarlington. Stage 2 submission from AHB will issue in July with an additional 9 units.
- Cluid Housing Association are finalising a Turnkey development, of 26 Units, on Rahan Road, Tullamore. Construction is to commence Summer 2020.

Turnkey Developments

- MacGregol, Birr: 12 Units Works resumed on the 18th May, 8 units will be delivered in 2020.
- Advertisement for expressions of interest for Turnkey schemes closed on the 28th May 2020. Currently assessing over 20 submissions across all MD's.

Age Friendly Strategy

The Age Friendly Alliance held its June meeting via Zoom. This meeting was well attended and there was appreciation allround for the great work and collaboration

between agencies and service providers. The level of collaboration and deliverance of such a wide range and comprehensive level of supports and services is to be commended. The Faithful **Fields** Newsletter continues to be produced and delivered on a fortnightly basis and is being received well across the county. Offaly Age currently working Friendly are conjunction with Westmeath Age Friendly on an Intergenerational Music project. This is in collaboration with Music Generation the Library services and LOETB.



Public Participation Network

The PPN continues to participate in the Offaly Community Response Forum providing updates on progress and concerns about the Community sector living with and post Covid 19.

The PPN Elections took place with new and returning reps taking up their position in

June 2020. The PPN would like to thank the following reps for their work with the PPN. Secretariat member Loughnan Hooper has stepped down after giving 5 years' service to the Secretariat. We also want to thank Jimmy Todd for his representation on the LCDC as a PPN Community representative. Sylvia Sweeney was elected as the Community Rep on the LCDC for a three-year term & Sinead McDonagh is returning as a Community rep for a further 3 years. Congratulations to all.

The PPN continues to present new information to membership on an ongoing basis as per directives both at National & Local level. The Midlands Regional PPN continue to meet with a view to delivering cross county services to membership, supporting the Community & Voluntary services during these challenging times.

Comhairle na nÓg

Offaly Comhairle na nÓg held a meeting with Cllr. Neil Feighery and Director of Services Sharon Kennedy on "Your Council Day" the 1st of July. It was a meeting to share knowledge and experience from the Council's perspective and from the perspective of a Councillor. It was a great opportunity for the young members to learn about each job.

Pride of Place

IPB Pride of Place is an All-Ireland competition which recognises the work that communities do all over the island. It will be held remotely this year due to Covid restrictions. The entrants from Offaly for 2020 are Lusmagh Development Group and Glendaniel Residents Association. Judging will take place in September and the online awards ceremony will be held in November.

ARTS

Music Generation Offaly Westmeath

MGOW Music Technology Course: A 6-week music technology and composition course has just been completed. Through a series of zoom sessions, and by making use of a learning management system (Google classroom) young people were introduced to making music online using an audio package and given the chance to work with a midlands based song writer and producer. We hope to produce a virtual concert of some of their compositions in the near future.



Cruinniú na n'Óg 2020

MGOW was involved in delivering sessions as part of the Cruinniú programme in both Offaly & Westmeath. From developing story and music sessions to family and teen sings – MGOW musicians delivered in excess of 5 hours of live music making online on Saturday 21st June.



Quality Framework

Along with all Music Generations, MGOW is in the process of implementing the Quality Framework — a flexible, non-prescriptive Framework which we use as a tool for the consideration and planning for Quality in our own particular context(s). The Quality Framework includes tools and templates that can be used to stimulate discussion about the goals of our work, to explore where we are achieving on our objectives and where we want to develop and grow.

We had already made a good start on selecting an area for review and introducing the musician team to the process and purpose of the exercise. We have been able to refocus our efforts during this time and collectively reflect on our progress, identify needs and next steps.



Summer Voices Online Singing Camp

MGOW have joined forces with Music Generation Louth, Sing Ireland and IMRO to create an on-line singing camp for teens. The camp will involve workshops in everything from singing and song-writing to rap.

The 3-day course will take place from 21st-23rd July and be led by Irish Youth Choir tutor and Chamber Choir Ireland member Alan Leech alongside workshop leaders and musicians from Music Generations Offaly Westmeath and Louth including extra sessions on Rap with Rapper Garry McCarthy (GMCBeats), Songwriting with Singer Songwriter Luan Parle, Vocal Sound with Irish Youth Training Choir Conductor Patrick Barrett and Warm Ups with Singer Helen Hassett.

Arts Office

Arts Grants: We are assessing the arts act grants, professional artist support grants and festival grants on a continual basis, with a view to aid community groups and artists find alternative means of engagement if their original proposal could not take place. In most cases the response is that the group will be rescheduling from Sept. The latest update is that several Arts Act Grants and Festivals are now on course for delivery.

Festivals Online



We are continuing to work closely with festivals. The majority of our granted festivals are now taking place both online and offline, advice and H&S guidelines are being provided. *Shakefest* – dance and cultural festival took place online in June and was an online success. We also assisted in promoting Cruinniú na nÓg.

Exhibition Programme

The exhibition programme for the Atrium has been suspended but we are looking into ways of hosting a virtual gallery space.

FilmOffaly Programme

We are working with several independent films on locations which are waiting to commence in Offaly later this year.

FilmOffaly Award 2019

The filming of this award is due to commence in Sep/Oct 2020. Screen Ireland has released specific H&S guidelines for the film industry and although challenging the production company is able to start planning for a shoot.



FilmOffaly Award 2020

Interviews took place in June 2020 over zoom and the winning script and production team chosen. Contract will issue soon.

FilmOffaly Mentoring Programme Evaluation of submissions for mentors took place in June, mentor selected was Helen Flanagan. Currently working with Helen to



promote the scheme to mentees and organise workshops for later in the year. Programme is in collaboration with LOETB, LEO and Screen Skills Ireland.

FilmOffaly

The Arts Office in conjunction with LEO are looking into the possibility examining funding potentials for the development of a Masterplan/Feasibility study on Film and Animation in Offaly, with a further development which would cover employment supports towards Project Manager, bursaries + residencies + incentives for industry. An application to Just Transition START is the first step in the process.

Event Co-Ordinator

The event organiser for Culture Night and Hullabaloo! has been selected and she is currently working closely with the Arts Office, our partners and artists with regard to formulating and online and offline programme for these events.

Culture Night

The Arts Office is concentrating on an online response for Culture Night. It is intended to produce a short showcasing our artists, venues and locations. 16 proposals were received from film production companies / filmmakers to undertake the Culture Night Film, same will be evaluated shortly. In addition, 13 proposals were received from artists wishing to take part in the film. There will also be some restricted physical independent events taking place.

Hullabaloo

The Arts Office are progressing to scheduling of workshops and events.

Midland Arts Magazine



Youth Arts

The Arts Office has been working with youth arts facilitator Oisín Robbins to create an online project entitled 'Capture Your Creativity'. Young creatives have been invited to capture their artwork (any medium) and submit same to us. The art work will be curated together and showcased though a short film on social media, depending on response there may be more than one film. The project aims to capture the range and diversity of youth art for ages between 12-20 years. This project aims to celebrate and showcase the creativity that's inside young people and to encourage young voices to be heard and to develop a youth-led, Youth Arts Forum for the county.

The Youth Arts report *The Makings Fostering Youth Creativity* – is ready for production, quotes for a digital design have been received and evaluated. The document will be deigned and disseminated online.

The intergenerational music project with Andy Spearpoint is currently on hold as engagement for this project is with older people and young people (between 16-24 years). The project is a collaboration with Music Generation and Anam Beo and the partners are investigating ways to progress it.

The Arts Office are one of the partners for an Arts Council funded award through their 'Invitation To Collaborate 'Funding – The lead partner in this project is Laois County Council Arts Office. The project is a regional project titled Mapping Arts Provision in Health Settings. Partner organizations are Laois County, County, Westmeath County Council, Offaly County Council, Music Generation OW, Anam Beo, Helium Arts, Waterford Healing Arts Trust (WHAT). The brief for a researcher for the project has been advertised and the partnership are awaiting submissions for evaluation.

develop links within the community to develop her oral history recording project, schools' writing and choral workshops, mentorship opportunities for local writers and events in conjunction with the That Beats Banagher Festival. Prior to the lockdown Jessica conducted a number of workshops with TY students, and local writers. Following lockdown Jessica arranged a 4-week series of online workshops with local writers plus arranging a summer mentorship programme for 6th

year students and adults. Further programming will be taking place throughout the summer.

Lough Boora

- The Deep Mapping project is nearing completion the final report will be available shortly.
- ITC Art in Landscape Research Project – Collaboration with Mayo County Council and Visual Arts Ireland. A national call was issued for researcher proposals/ tenders, closing date due in mid-June.

Creative Edenderry

An ongoing intiative in conjunction with Voluntary Arts Ireland and Offaly Libraries that encourages discourse and awareness of the arts in Edenderry with the view to building a strong Creative Network.



The development of the Creative Edenderry network is progressing well with regular meetings taking place with a cohort of interested people. The Group are progressing with the development of an Arts project, looking at the theme of Our Place, with a focus on industrial heritage – the new project is titled Shoes of Edenderry and will include curating stories, images,



anecdotes from locals around the old shoe factory. The group are preparing an event for Culture Night. An application from the IPB / Galway 2020 was made in conjunction with the group with a planned series of events to take place in March 2021.

Birr Writer's Retreat

Evaluation of submissions for the Birr writers's Retreat took place in June. Four candidates were awarded.

Capital Projects Tullamore Community Art Centre

They are working hard to adjust to social distancing guidelines and ensuring their businesses are safe for customers.

Many supports are available for the industry through Fáilte Ireland and the tourism team have been working closely with their representatives from IAE & IHH to assist and support the trade where possible.

Offaly Tourism Marketing held their first 'virtual' meeting on 18th June. It was very

welcome by the trade and well attended. Fáilte Ireland's Lorraine Sheehan spoke to members on updates and further assistance available to them. It was a good opportunity for the trade to discuss their issues, findings and learnings during this difficult time.

The Tourist Office in Tullamore opened its doors again to visitors on 29th June after being closed for a period of ten weeks. Once again the loyal volunteers have assisted in making this possible and we thank them greatly for their continued support.

Offalv Tourism's national Summer marketing campaign launched on 15th June. The national radio campaign ran for a period of 4 weeks on Today FM & Newstalk. It included a week long promotion on Today FM's Fergal Darcy afternoon show. There were daily prizes of a stay for 2 nights and dinner in the newly refurbished Tullamore Court Hotel and the grand prize at the end of the week promotion was a 5 night stay on board luxurv cruiser with Silverline Both the adverts and the Cruisers. promotion has been very well received and has definitely boosted Offaly's profile nationwide.

For the first time ever, Offaly tourism was delighted to collaborate with its neighbours in the midland counties to jointly promote the area on local radio. The 'Magical Midlands' adverts began broadcasting on Midland 103 on 1th June and are running for a period of 4 weeks. The campaign consisted of three county specific adverts for Offaly, Laois & Westmeath. common message at the beginning and ending of the adverts is to enjoy the 'Magical Midlands'. The adverts encourage the Midlanders to get out and

Fáilte Ireland's Irelands Ancient East have come together with Offlay LEO and Offaly Tourism to offer tailor made free online courses for the hospitality and tourism businesses within the county.

There are three different two-hour training courses available to the trade; the first once taking place Thursday 16th July. These are a valuable resource for the tourism providers in the county as they re-open and require assistance in different areas of the business.

The tourism team are preparing for this year's virtual Meitheal commencing on 2st July. Fáilte Ireland's largest in-Ireland event was cancelled in March due to COVID 19. The event which hosts over 300 international buyers is now going online for seven days and Offaly Tourism is delighted to be represented for the first time.

Offaly Tourism have commissioned videography & photography for this Summer so look out for the cameramen and photographers when you're out and about. The tourism team are looking forward to Offaly Tourism first ever dedicated tourism videos being available to assist in promotion soon.

LOCAL ENTERPRISE OFFICE

The Local Enterprise Office Offaly team continues to work remotely and provides a full service to new and existing enterprises in Offaly. In addition to the core LEO staff, two additional staff members – Ann Marie O'Brien and Aideen Moore from Offaly

County Council have been temporarily assigned to the LEO office. These additional staff members are providing much needed assistance to deal with the unprecedented numbers of business owners contacting the Local Enterprise Office. Orla Martin, Head of Enterprise acknowledged that the extraordinary efforts of staff and expressed her thanks to all members of the Local Enterprise Office for their hard work and commitment to support and help Offaly businesses.

Users have access to eBooks, eAudiobooks, eMagazines, eNewspapers, educational courses, language learning, free music and film streaming. Cruinniú na nÓg Progamme 2020



Cruinniú na nÓg was hosted entirely online in 2020. The proposed programme of events originally planned for Cruinniú was cancelled at the end of March due to Covid-19. The decision was made to move the entire programme online in mid-April with an open call for creative facilitators with online content.

All submissions were reviewed and assessed from both a value for money perspective and to ensure quality cultural content. By using a mixture of local and national creative facilitators, Offaly County Council organised 66 events which can be watched here. A blended approach was adopted with a mixture of videos and webinars featuring 13 different providers on three different social media platform – Facebook, Twitter and Instagram.

47 videos and 8 posts were posted on Facebook which generated 11,388 views with 1,959 people engaging with the content and a reach of 50,540.



6 posts featured on Twitter with a reach of 3,059 and engagement of 112.



The reach of our 6 Instagram posts was 736 with 26 likes.
