

Unauthorised Development Complaints Guidance.

To note: <u>**Civil Matters**</u> or matters that are addressed under other legislation and codes, are not valid Planning Enforcement issues and should not be submitted. Examples include:

Encroachment including overhanging trees etc.	Property Ownership
Private Rights of Way	Trespass
Civil Boundary Disputes	Matters related to Private Drains
Structural Damage to private property resulting from construction works	* Noise Pollution (unless noise breaches conditions of a planning permission)
Other types of private nuisance	Other legal issues

Planning Enforcement Frequently Asked Questions.

1. What information do I need to provide when making a complaint?

- Exact location of the site, Eircode and a site location map, if possible.
- Details (where known) of the property owner/occupier/developer.
- Details of the suspected breach/unauthorised development.
- Date the alleged unauthorised development commenced.
- Photographs where possible.
- Your own name, address, email and a daytime contact number.

2. What is Unauthorised Development?

Unauthorised development typically falls into one of three categories:

- 1. Where planning permission was required but not obtained.
- 2. Where a development was not finished in accordance with the conditions or planning permission that was approved for it.
- 3. Where a development does not comply with the conditions that allow it to be excluded from planning permission, e.g., a boundary wall constructed to a height more than 1.2m to the front of a property, or 2m to the side or rear.





- **3.** How can I find out if a development has Planning Permission? Search our online Planning Database to find out if the development has planning permission by clicking this link
- 4. What should I do if I think that there is a breach of the Planning Regulations? You can complete and return a <u>Planning Enforcement Complaint Form</u> by email to <u>planningenforcement@offalycoco.ie</u> or by post to the address below:

N.B. The Planning Enforcement Team cannot review any alleged complaint until the <u>Planning Enforcement Complaint Form</u> has been completed and returned to us.

5. Will I be kept up to date on the status of my complaint?

Once a complaint is received you will receive an acknowledgement in writing. Offaly County Council is not permitted to provide updates of the process, as the disclosure of such information may prejudice future potential legal action which may be instigated by Offaly County Council.

However, should you become aware of significant further details / information on the case (e.g. regarding the identity of the developer / owner etc.) then please bring such information to our notice, in writing. Should Enforcement Notice be issued, you as the complainant, will be notified in writing.

6. What are the penalties for breaching planning laws?

The penalties for breaches of planning law depend on the nature of the offence but if found guilty, could result in a criminal prosecution and a fine and/or a prison sentence. For more information, please click on the link to: <u>A Guide to Planning Enforcement</u>.

7. Freedom of Information?

Complaints regarding unauthorised development constitute part of the Council's records for the purposes of the above acts. The Council will endeavor to maintain as confidential any complaints made to it in confidence and in good faith. The Council cannot, however, give absolute guarantees on this as requests under the Freedom of Information Act can be appealed by requesters to the Information Commissioner.
