1. Confirmation of Minutes:

Mr. T. Shanahan, D.O.S., agreed to come back to Cllr D. Dolan with responses to housing issues/queries raised by him at the May monthly meeting. It was also agreed to give housing update at the June meeting.

2. Water & Environment Report

Ms. M. Gaughran, A.O., presented the Water & Environment Report, as circulated, to the members. The members welcomed the Report, raising a number of issues incl.: issue of difficulty of residents in flood risk areas getting insurance cover; litter and dog fouling problems; which were noted and responded to by Ms. M. Gaughran.

Ms. M. Gaughran then left the meeting.

3. Update on Tullamore Street Enhancement Programme.

Mr. T. Shanahan, D.O.S., updated the members on Tullamore Street Enhancement Programme. The Tender Documents were ready for advertising, the expectation was that the tenders would be assessed in June, followed by appointment of contractor in July.

4. Derelict Sites Report

Mr. E. Kelly, E.P., updated the members on Derelict Sites activity in Tullamore MD. Ten sites were identified for follow up. The owners were due to be contacted in the coming weeks. The requirement for the owners was to carry out repair works on external façade only. He advised that the tens sites identified were the start of the process, further sites to be identified and action taken. The progress report was welcomed by the members.

(i) "That the Municipal District of Tullamore contact the Department of Transport seeking funding for improvement works at Erry Mill junction and at the Scouts Den junction at Bridge Street in Clara to make the junctions safer for motorists and pedestrians."

It was agreed to defer this motion back to the June monthly meeting.

(ii) "That the Municipal District of Tullamore install bus shelters in Clara town centre and in Tubber Village to accommodate bus users.
