Dear Councillor,

Please find attached herewith the **Road Works Programme** for the year 2023. The programme is funded through three National Funding bodies, Transport infrastructure Ireland (TII) the Department of Transport (DoT) and the National Transport Authority (NTA), along with funding allocated by Offaly County Council in the 2023 adopted budget.

The initial grant allocations for 2023 from TII, DoT and the NTA are set out below with the figures for 2022 shown alongside for comparison purposes.

02 Roads Programme Funding Source

As in previous years, transfers from the Restoration Improvement Grant to the Discretionary Grant is not allowable as notified in Circular RW1/2018.

Own Resources Funding: Direct Funding from Offaly County Council plays a vital role in delivering the Annual Roads Programme and 2023 will be no exception. The Department of Transport, (DoT) has again advised Local Authorities under Department of Transport Circular RW 02/2023, Section 38 accompanying the 2023 Non National Roads grant allocations as follows;

Own Resources

38. The commitment of local authorities to contribute significantly from their own resources towards the cost of improving and maintaining the regional and local roads network is essential. In particular it is vital that local authorities at least maintain and increase, where possible, monies available for the maintenance and strengthening of road pavements.

It may be necessary for local authorities to postpone major widening and realignment schemes to achieve this objective, but the first priority must be the satisfactory protection of the existing road network.

In 2023, Offaly County Council has allocated **€2,246,269** (€2,156,269 Local Roads + €90,000 Footpaths) from our Own Resources, which is an increase of 8.15% from the 2022 allocation of **€2,077,130**. The Winter Service allocation from our Own Resources will increase by €25,000 to €100,000 for 2023. The allocation of €150,000 for Severe Weather Events will remain at €150,000 for 2023.

Additional to the Local Road supports from our Own Resources, Offaly County Council have also allocated €949,500 for Public Lighting and a further €100,000 for the PLEEP project from our Own Resources.

Transport Infrastructure Ireland (TII): Offaly County Council has received a significant increase in funding from Transport Infrastructure Ireland (TII) which equates to €8,761,012 which is an increase on our initial roads allocation of €2,763,000 in 2022.

The initial allocation is for maintenance and improvement of the National Road Network and the completion of the final stages of the Grand Canal Greenway and Greenway Links. Funding for HD28 Pavement Renewals, HD15 & HD17 Minor Works for road safety schemes will be agreed with TII throughout the year and will be additional to the initial €8,761,012 received.

The TII have made a significant funding commitment with regards to completing the remaining approximately 16km of the Grand Canal Greenway via the allocation of €3,880,000 in funding for 2023.

The TII allocation includes €4,000,000 for pavement improvement works on the N62 on two separate schemes namely N62 Cloghan to Stonestown and N62 Boolinarig Little to Derrinlough. There is also an allocation of €200,000 to continue the feasibility and planning stages for the N62 Cloghan to Derrinlough minor works project. Offaly County Council will work with TII to secure further funding as required throughout 2023 as schemes are progressed and completed.

The responsibility for the maintenance and upkeep of the Motorway network nationally is the responsibility of the TII who in turn has contracted out this work to private contractors. Approximately 15km of the M6 and M7 pass through County Offaly. There is an allocation of €9,117 from TII for Motorway lighting maintenance.

Unfortunately, TII have not allocated any funding for the N52 Tullamore to Kilbeggan Link in 2023 to date. The Option Selection Report is now being finalised and should be published in the coming weeks.

Department of Transport: Under the Regional and Local Road Grant Allocation from the Department of Transport, Offaly County Council received a total Grant allocation of €15,539,300 which is an increase of €660,869 when compared to the 2022 allocation of €14,878,431.

This year's allocation includes funding for the completion of Stage 2 of the Edenderry Inner Relief Road and the completion of tender documentation for the Birr North Distributor Road. There is an allocation to commence the Strategic Assessment Phase for the Birr South Eastern Distributor Road. There is also an allocation of €1,000,000 for our Peat Roads Pilot Project.

The National Transport Authority (NTA): Offaly County Council received a Grant allocation of €3,009,382 for 2023 from the NTA which is a reduction of approximately €672,526 when compared to the €3,681,908(excl Bus Stops) allocation for 2022. Approximately €1,973,720 of the 2023 allocation has been carried over from 2022 to continue funding schemes commenced in 2021/ 2022. Due to the multi annual nature of the Active Travel Programme the expenditure profile per year is not intended to account for the full yearly allocation.

It is important to recognise that schemes approved for Offaly County Council are all on a predominantly 18-24 month delivery programme. There are some schemes with a potentially broader delivery timeline such as the new Tullamore Area Based Transport Assessment and the Spollenstown Bridge Crossing of the Railway Line. All of these delivery timelines are subject to a myriad of dependencies that can potentially extend the scheme delivery timeline.

There are 22 No. schemes included under the Active Travel Investment Programme for the 2023 programme for Offaly. 17No. Schemes are underway since 2021/2022 with 5 No. new schemes due to commence in 2023.

Community Involvement Scheme: Offaly County Council received an allocation of \in **301,500** for 2023, which represents a reduction of \in 67,000 when compared with the allocation of \in **368,500** received in 2022.

Local Improvement Scheme: Offaly County Council received an allocation of **€348,777** for 2023 which represents a reduction of **€31,983** when compared with the allocation of **€380,760** received in 2022 for Local Improvement Schemes.

CLÁR 2023: Offaly County Council have yet to receive an allocation under CLÁR for 2023 from the Department of Rural and Community Development.

Public Lighting Energy Efficiency Project (PLEEP): Kilkenny County Council acting as Lead Authority on behalf of the (9) Counties in this Region have now brought the PLEEP project to the onsite Construction Stage. Works are programmed to commence in Offaly in early Q3 of 2023 with a programmed delivery timetable of approximately 2 months. The installation works associated with the PLEEP project are scheduled for completion by the early part of Q4 2023.

Categories of Road Maintenance

Restoration Improvement (RI): This allocation is targeted towards the strengthening programme and is hugely important in terms of maintaining the existing Road network. It caters for pavement overlay works and for complete road rehabilitation works as well as for drainage works where required.

Restoration Maintenance (RM): The purpose of the Restoration Maintenance grant is to protect the structural integrity of the road by way of surface dressing (and necessary basic preparatory works) through the sealing of the road surface to protect the road pavement layers from the adverse effects of the ingress of water and to maintain Skid Resistance on our Road Network. A basic Surface Dressing is defined as the uniform application of a bituminous binder sprayed onto a road surface followed by a layer of single sized chippings. Periodic maintenance aims to protect the structural integrity of the Regional and Local road network and is generally addressed using Surface Dressing.

Discretionary Grant (DG): Local Authorities can assign the Discretionary Grant to a variety of maintenance and repair works on roads and footways and it can also be used for winter maintenance purposes. Routine maintenance would typically

include activities such as roadside verge clearing, grass cutting, cleaning of silted ditches and culverts, patching, pothole repair and repair of edge defects. Urgent Maintenance is undertaken for repairs that cannot be foreseen but require immediate attention, such as collapsed culverts or landslides that block a road. Routine and Urgent Maintenance can be charged to the Discretionary Grant programme.

The amounts that each Local Authority receives from the Department of Transport under these three grant programmes Restoration Maintenance (RM), Restoration Improvement (RI) and Discretionary Grant (DG) are based principally on road lengths.

The detailed programmes to be completed under the previously mentioned funding categories in each Municipal District are included in Appendix C.

03 Key Actions for 2023

The following is a list of Key actions and projects that the Roads and Transport Department plan to progress in 2023:

- Complete the National, Regional and Local Roads Improvement Programme in accordance with the 2023 Grant Allocations and apply for and deliver capital maintenance schemes on National Roads;
- Complete the 2023 identified Road Safety Improvement Schemes on Regional and Local Roads and work with TII to progress Roads Safety Schemes on National Roads;
- Promote Road Safety awareness in association with the Road Safety Authority, the Gardaí and TII(Offaly County Council Road Safety Working Group); progress Road Safety Initiatives in Offaly;
- Deliver Offaly County Councils Winter Maintenance Service Plan and Severe Weather Response in accordance with the 2023 – 2024 Winter Maintenance & Severe Weather Response Plans;
- Continue to develop and complete the Grand Canal Greenway and commence the design of and procurement documentation for associated links from our Towns and Villages as identified under our Pathfinder proposal issued to the NTA in 2022;
- Operate and maintain the machinery yard fleet in a safe and efficient manner. Continue with App based vehicle inspections sheets. Commence the migration of the corporate Fleet towards Zero Emission Vehicles. Upgrade the access systems for the Machinery Yard to restrict vehicular movements to only Offaly County Council staff, remove all non-construction based services from the machinery yard footprint into the storage buildings onsite with access via the car park into the main office(no access to the yard permitted). Migrate the corporate fleet to Fuel Cards and reduce the reliance

on the bulk storage of fuel. Operate and expand the Zero Emission Vehicle Infrastructure onsite (EV DC Fast Charging point).

- Continue our programme of maintenance, repair and upgrading of our Public Lighting stock in collaboration with our appointed Public Lighting maintenance contractor. Tender a new Public Lighting Maintenance contract to commence in Q3 2023.
- Manage the PLEEP installation works which are due to commence in Q3 2023 which will result in the replacement and upgrade of 4842 lighting units to LED units;
- Review and identify efficiencies that may be achieved with the existing Bus Network configuration in County Offaly in order to underpin our modal shift ethos under both Active Travel Schemes and our Organisational Climate Action Plan.
- Continue our programme of upgrading Pedestrian Crossings;
- Continue our Bridge rehabilitation programme, develop plans and seek funding for further schemes;
- Progress the Community Involvement Scheme, Local Improvement Scheme and CLAR Schemes funded by DTTAS and DRCD;
- Undertake Health & Safety Inspections;
- Continue to engage with stakeholders and report on planning applications & Strategic Infrastructure proposals;
- Continue to issue Roads & Services in charge letters and Abnormal Load Permits;
- Deliver our Peat Roads Pilot scheme on the R400 in the Edenderry Municipal District in 2023.
- Publish the N52 Tullamore to Kilbeggan Option Selection Report in collaboration with the TII and the Westmeath National Design office.
- Progress the N62 Cloghan to Kennedys Cross peat replacement Minor Works Scheme;

- Deliver Stage 2 of the Edenderry Town Inner Relief Road Specific Improvement Scheme;
- Progress the Birr North Distributor Road R439 Banagher Road to N52 Tullamore Road Specific Improvement Scheme to Detailed Design/Procurement stage;
- Deliver a Strategic Assessment Report (SAR) for the Birr South Eastern Distributor Road linking the N52 and the R440;
- Deliver on the agreed NTA funded Active Travel Programme for 2023;
- Assess the potential for and expand on the number of Zero Emission Vehicle Charging Infrastructure locations across our entire County in collaboration with Zero Emission Vehicles Ireland (ZEVI).
- Identify and incorporate new methodologies and approaches to service delivery, which will provide a reduction on the roads Carbon output for 2023.
- Ensure that Health and Safety remains the primary consideration in all works delivered in 2023.
- Co-ordinate and review expenditure on an ongoing basis throughout 2023 due to potential future rising inflation, increased fuel costs, material costs, contractor costs and compliance costs.
- Assist and support the activities of the Municipal Districts throughout 2023.
- The Roads Team will promote a greater emphasis on communicating to our local communities the benefits and strategically important roles that local communities can play in assisting and in some cases delivering Climate Action changes through proactive engagement with Roads and our Municipal District Colleagues.

04 Road Safety/Health and Safety

2023

Road Safety 2023

The Roads Department have completed the final Draft of Offaly County Councils Road Safety Plan 2023-2030. The report is to issue to all working group stakeholder members and is due to be ratified in early Q2 2023 by the group.

Health and Safety 2023

When undertaking the Roads Programme for 2023 the key objectives are to ensure that the work is carried out in a safe manner for all stakeholders including the staff involved and the public within the vicinity of the works.

In order to achieve this objective all works must be;

- Safely planned in advance.
- Works undertaken by trained, competent staff and contractors.
- Roles such as Project Supervisor Design Stage(PSDP) and Project Supervisor at Construction Stage(PSCS) must be assigned and appointed.
- All works must be carried out in compliance with current Health and Safety Regulations and underpinned by a Site Specific Safety Management Plan and associated documents, including Health and Safety Plans, Safe Systems of Work, Risk Assessments and Traffic Management Plans.
- The communications of these documents are critical to ensuring that work practices are carried out safely on each site.

These above core tasks ensure Offaly County Council continues to manage the Roads Programme in a safe manner and these key principles will be required to maintain and ensure a successful outcome in 2023.

A Health and Safety review was completed in February 2023 and this will be used to set out the targets and areas for improvements in 2023.

The Department of Transport has allocated €47,500 under the Training Grant in order to strengthen and promote Health and Safety approach towards the Roads Programme in 2023.

05 Report on 2022

In 2022 the Roads and Transport Department of Offaly County Council continued to build on delivering new sustainable infrastructure to promote modal shift across our entire County to Walking, Cycling and Zero Emission Vehicle. There has been and will continue to be targeted investment towards our existing infrastructure in order to maintain, upgrade and expand our existing road networks in order to facilitate growth across our entire County.

Grand Canal Greenway:

In collaboration with the TII and Waterways Ireland work on delivering the remaining sections of the Grand Canal Greenway continued throughout 2022. It is envisaged that this critical infrastructural corridor will be completed in its entirety in 2023. The following schemes were commenced or delivered in 2022;

- Pullough to Henseys Bridge section of the Greenway and is due for completion
- Linking Grand Canal Greenway to Killina Presentation Secondary School Gorteen to Rathcobican section of Greenway completed in 2022 (4.2Km) (380m).



Electric Vehicle Charging Points (DC/Fast Charging):

The Roads Department of Offaly County Council have been working in partnership with Eir/Easy Go in order to delivery 11 new DC charging points across our County. The proposed scheme is classified as a public private collaboration designed to provide DC charging points across critical nodes on our Roads Infrastructure while also serving our rural communities in order to promote our migration as a County towards Zero Emission transport options.

Offaly County Council secured funding from the Department of Transports Zero Emission Vehicle Ireland (ZEVI) for the installation of two fast charging points at Áras an Chontae and the Machinery Yard in Tullamore as part of a pilot scheme in

An overall investment facilitated by and in some cases delivered by Offaly County Council of approximately €650,000 has provided a foundation for our County to commence the migration towards Zero Emission vehicles in 2022.



Birr North Distributor Road:

Design works commenced in 2022 on the Birr North Distributor Road with a view to construction commencing in Q1/Q2 of 2024 subject to approvals and funding.

The objective of the proposed Road Scheme is to create a road link between the Tullamore Road (N52) at Woodlands and the Birr to Banagher Road at Cappaneale (R439). This critical link will:

- relieve congestion in Birr Town by providing an alternative to the existing routes through the town.
- provide better access to the national road network for major local industry,
- open up zoned development lands,
- provide improved access to St Brendan's Secondary School,
- allow the tourism potential offered by Birr Castle and the town's historic and unique Georgian town centre to be realized.

Edenderry Inner Relief Road:

Stage 1 of the Edenderry Inner Relief Road was delivered by the Edenderry Municipal District Office in 2022. Stage 2 is currently scheduled to commence construction in early 2023.



Birr South Eastern Distributor Road:

An application for funding to commence Design works on the Birr South Eastern Distributor Road in 2023 was submitted to the Department of Transport for their consideration in Q4 of 2022.

Peat Road Pilot Scheme:

Tender documentation were submitted and approved by the Department of Transport for a full reconstruction of 600m of the R400 in Edenderry in 2022 with a construction start date of Q2 2023.

Due to significant Road Failures on our Roads constructed over Peat subgrades due to the extended dry spell over the summer of 2022 we sought and received approval from the Department of Transport for the reassignment of the €800k allocation for Peat Roads to address immediate Health and Safety risks across the County. Due to the scope and severity of the failures the Department also allocated additional funding to be targeted to the worst areas to a maximum additional spend of €1.2million.



Road Safety 2022 Review

The Roads Department have completed the final Draft of Offaly County Councils Road Safety Plan 2023-2030. The report is to issue to all working group stakeholder members and due to be ratified in early Q2 2023 by the group.

Health and Safety 2022 Review

Notwithstanding the excellent safety record within Offaly County Council for 2022. All Stakeholders must be conscious of the facts that 26 fatalities occurred in the wider national workplace in 2022, 7 of these fatalities occurred in the construction industry. The Management Team and Senior Management group carried out a number of inspections during 2022; this will remain a key focus for 2023 along with tracking the number of inspections carried out by each department and Directors attending key quarterly health and safety meetings in their respective Departments.
